**THE HERTFORDSHIRE (HIGH STREET, HEMEL HEMPSTEAD)
(PROHIBITION OF VEHICLES DURING EVENTS) ORDER 2012**

The Hertfordshire County Council in exercise of their powers under Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Hertfordshire (High Street, Hemel Hempstead) (Prohibition of Vehicles during Events) Order 2012" and shall come into operation on Tuesday 29 April 2014.
2. Interpretation -

In this Order
'authorised market stall' means – a market stall located within the restricted area and licensed by Dacorum Borough Council.

'Market' has the meaning as - a Market created by Dacorum Borough Council under the provisions of The Food Act 1984.

"authorised event" has the meaning as any event authorised or licensed under any enactment by Dacorum Borough Council to be held on the Highway.
3. Save as provided in Article 4 of this Order no person shall cause or permit any vehicle to enter or be in that length of High Street, Hemel Hempstead as specified in the Schedule to this Order (hereinafter referred to as the restricted area) whilst any authorised event or market is being held within the restricted area, provided that signs to indicate the effect of this Order are in place and are clearly displayed.
4. Nothing in Article 3 of this Order applies to the length of road restricted by that Article (which said length of road is referred to in this Article as "the restricted area") in relation to –
 - (a) A vehicle being used for Fire and Rescue, Police or Ambulance purposes during the course of an emergency.
 - (b) A vehicle authorised by Dacorum Borough Council for the purpose of setting up and dismantling authorised market stalls.
 - (c) Market trader's vehicles being used in connection with the setting up and running of authorised market stalls.
 - (d) A vehicle being used in connection with the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position and which cannot reasonably be used for such a purpose without entering and stopping in the restricted area;
5. In accordance with Section 92 of the said Act of 1984 when the provisions of this Order are operative, barriers will be placed across that length of High Street, Hemel Hempstead as specified in the Schedule to this Order.

6. The Hertfordshire Council in making this Order are satisfied that this Order is required to avoid the likelihood of danger arising to persons using the road during events and markets as specified in the schedule to this Order.
7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

length of High Street, Hemel Hempstead – prohibition of vehicles during events and markets

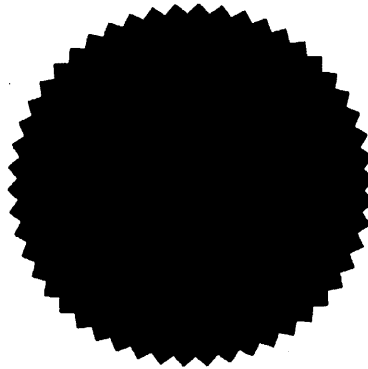
High Street between its junction with Queensway and a point 3 metres south east of a

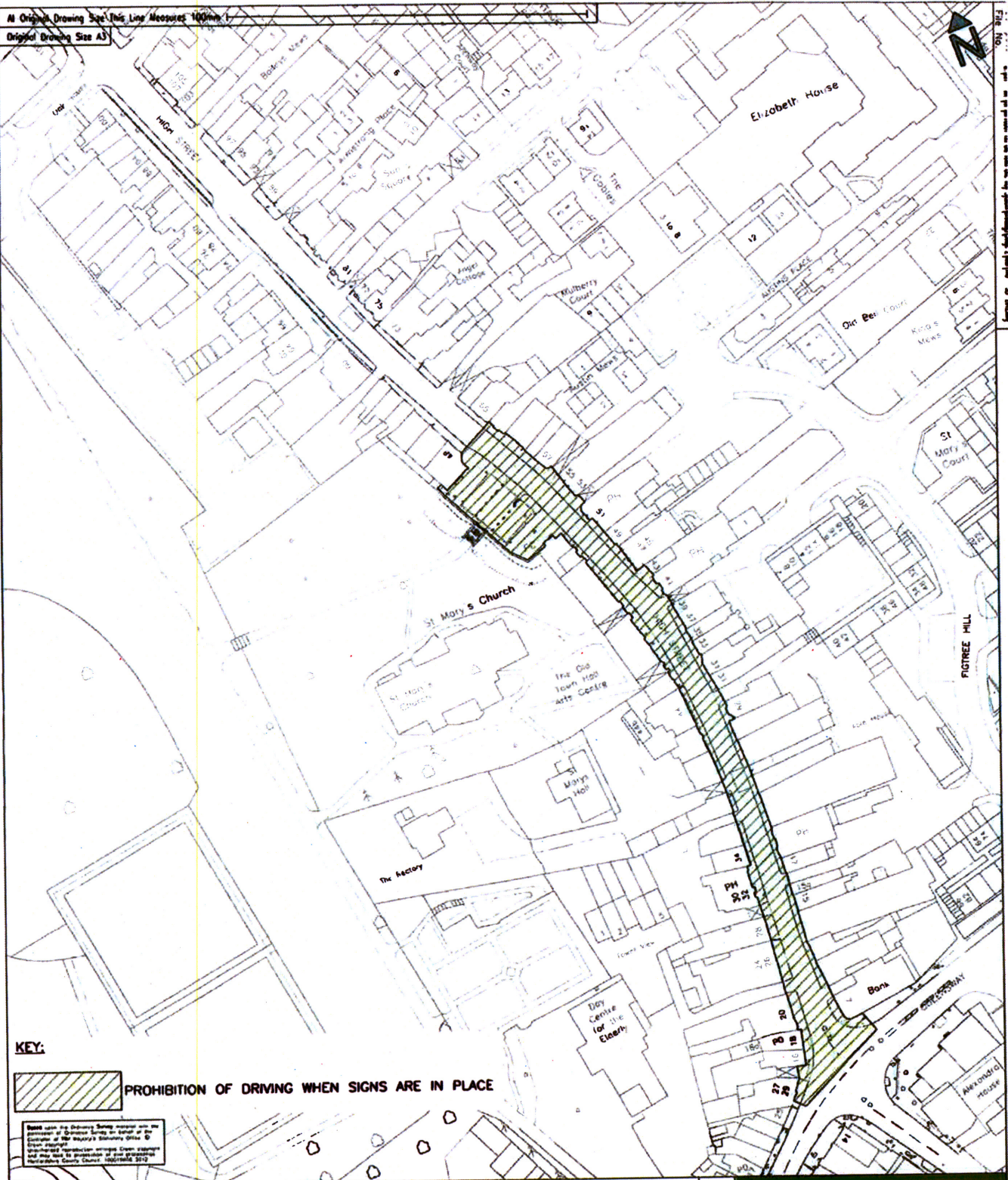
