ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF DACORUM (WATERHOUSE STREET, HEMEL HEMPSEAD) (PROHIBITION OF STOPPING AND WAITING EXCEPT TAXIS) ORDER 2014

Dacorum Borough Council, pursuant to the arrangements made under Section 19 of the Local Government Act 2000 with The Hertfordshire County Council in exercise of their powers under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984, (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

- 1. This Order may be cited as "The Borough of Dacorum (Waterhouse Street, Hemel Hempstead)(Prohibition of Stopping and Waiting Except Taxis) Order 2014" and shall come into operation on Thursday 23 April 2015.
 - In this Order Taxi shall have the meaning as given in Regulation 4 of The Traffic Signs Regulations and General Directions 2002 (SI 2002/3113)
- 2. Save as provided in Articles 3 and 4 of this Order, no person shall cause or permit any vehicle to stop or wait at any time in those lengths of Waterhouse Street, Hemel Hempstead as specified in the Schedule to this Order.
- 3. The restrictions imposed by Article 3 to this Order shall not apply to -
 - (a) a taxi which is stopped for as long as is reasonably necessary for the purpose of picking up or setting down passengers and their luggage; or
 - (b) a taxi, occupied by its driver, which is waiting for the purpose of plying for hire.
- 4(1) Nothing in Article 2 of this Order applies to the lengths of road restricted by that Article (which said lengths of road are referred to in this Article as "the restricted area") in relation to
 - (a) a vehicle being used for Fire and Rescue, Ambulance or Police purposes.
 - (b) anything done with the permission of or at the direction of a Police Constable in uniform; or with the permission of a Civil Enforcement Officer appointed by Dacorum Borough Council.
 - (c) a vehicle which is prevented from proceeding by circumstances beyond the drivers control or which has stopped in order to avoid injury or damage to persons or property or when required to do so by law;
 - (d) a vehicle which is stationary in order that it may be used for one or more of the purposes specified in sub-Article (2) of this Article and which cannot reasonably be used for such a purpose without stopping in the restricted area;
 - (e) a marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may be reasonably necessary for postal packets to be delivered or collected;

In this Article -

The expressions "universal service provider", "provision of a universal postal Service" and "postal packet" shall bear the same meanings as in the Postal Services Act 2000.

- (2) The "purposes" referred to in sub-Article (1)(d) of this Article are -
 - (a) any operation involving building, demolition or excavation;
 - (b) the removal of any obstruction to traffic;
 - (c) the maintenance, improvement or reconstruction of a road;
 - (d) constructing, improving, maintaining, or cleaning of any street furniture; or
 - (e) the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 5. The provisions of the following Orders are hereby revoked but only in so far as they affected by the restrictions imposed by this Order -

The Hertfordshire (Waterhouse Street, Hemel Hempstead) (Prohibition of Stopping and waiting Except Taxis) Order 2010.

The Hertfordshire (Waterhouse Street, Hemel Hempstead) (Restriction of Waiting) Order 2010.

The Borough of Dacorum (Hemel Hempstead) (Prohibition and Restriction of Waiting) (Consolidation) Order 2003

6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

SCHEDULE

lengths of Waterhouse Street, Hemel Hempstead - no stopping or waiting at anytime except taxis.

Waterhouse Street (west side)

- (a) from a point 57 metres north of a point in line with the projected northern kerbline of Moor End Road northwards for approximately 88 metres to a point 1.5 metres south of a point in line with the projected southern kerbline of Bank Court.
- (b) from a point 2.5 metres north of a point in line with the projected northern kerbline of Bank Court northwards for approximately 115 metres to a point 33 metres south of a point in line with the projected south kerbline of Bridge Street


