**THE BOROUGH OF DACORUM (HIGH STREET SOUTH, NORTHCHURCH)  
(PARKING PLACES) ORDER 2015**

Dacorum Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000(a) and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000(b) with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984(c) (“the Act of 1984”) and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:


1. This Order may be cited as “The Borough of Dacorum (High Street South, Northchurch) (Parking Places) Order 2015” and shall come into operation on 20 July 2015
2. Those lengths of High Street South, Northchurch specified in the Schedule to this Order are designated for use as parking places limited to 30 minutes waiting with no return within the next 2 hours, between 8:00am and 8:00pm on Monday to Sunday inclusive.
3. Save as exempted by Articles 4 and 5 of this Order where in Article 2 of this Order a length of High Street South, Northchurch is described as designated for use as a parking place, the driver of a vehicle shall not permit the vehicle to wait in that parking place:-
  - (a) in contravention of the restrictions imposed by Article 2.
  - (b) unless it is wholly parked within the marked limits of the parking place.
- 4.(1) Nothing in Article 2 of this Order applies to the lengths of road restricted by that Article (which said lengths of road are referred to in this Article as “the restricted area”) in relation to –
  - (a) a vehicle being used for Fire and Rescue, Ambulance or Police purposes;
  - (b) anything done with the permission of or at the direction of a Police Constable in uniform; or with permission of a Civil Enforcement Officer as defined by the Traffic Management Act 2004 and appointed by Dacorum Borough Council;
  - (c) a vehicle which is prevented from proceeding by circumstances beyond the driver’s control or which has stopped in order to avoid injury or damage to persons or property or when required to do so by law;
  - (d) a vehicle which is stationary in order that it may be used for one or more of the purposes specified in sub-Article (2) of this Article and which cannot reasonably be used for such a purpose without stopping in the restricted area;
  - (e) a marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may be reasonably necessary for postal packets to be delivered or collected.
- (2) In this article the expressions “universal service provider”, “provision of a universal postal Service” and “postal packet” shall bear the same meanings as in the Postal Services Act 2000.
- (3) The “purposes” referred to in sub-Article (1)(d) of this Article are –
  - (a) any operation involving building, demolition or excavation;
  - (b) the removal of any obstruction to traffic;
  - (c) the maintenance, improvement or reconstruction of a road;
  - (d) constructing, improving, maintaining, or cleaning of any street furniture; or


- (e) the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.
5. (1) Nothing in Article 3 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc, to wait at any time in the lengths of road specified in the Schedule of this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road). Provided that the vehicle shall park within the marked limits of the parking place.
- (2) In this Article -
- “disabled person's vehicle” has the same meaning as in Section 142(1) of the Act of 1984;
- “disabled person's badge” has the same meaning as given in Regulation 3(1) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
- “parking disc” has the same meaning as given in Regulation 8(5) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000; and
- “relevant position” has the same meaning as given in Regulation 4 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.
6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
7. The provisions of the following Order are hereby revoked only in so far as they are affected by the restrictions imposed by this Order –
- The Borough of Dacorum (Berkhamsted) Prohibition and Restriction of Waiting (Consolidation) Order 2003.
8. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the act of 1984 or by any other enactment.

**Schedule: Parking Places - Waiting Limited to 30 minutes, no return within next 2 hours:  
Monday to Sunday inclusive: 8.00am to 8.00pm**

<b>Column 1 STREET NAME</b>	<b>Column 2 SIDE OF STREET</b>	<b>Column 3 LOCATION</b>
High Street South, Northchurch	North East	From a point 2 metres southeast of a point opposite the party wall of Nos. 131 and 133 High Street, Northchurch northwestwards for a distance of 10.8 metres
High Street South, Northchurch	South West	From a point 10.6 metres southeast of the southeastern kerbline of the access road situated between Nos. 135/137 and 139/139b High Street, Northchurch southeastwards for a distance of 15 metres
