ROAD TRAFFIC REGULATION ACT 1984 ORDER UNDER SECTION 14 (1)

THE HERTFORDSHIRE (TEMPORARY TRAFFIC MANAGEMENT MEASURES ON VARIOUS ROADS AND FOOTWAY IN HEMEL HEMPSTEAD) ORDER 2016

WHEREAS by Section 14, sub-section (1) of the Road Traffic Regulation Act 1984, subject to the provisions of the section if a Highway Authority are satisfied that traffic on any road and pedestrians on any footway should by reason of any works being executed or proposed to be executed on or near the road or footway be restricted or prohibited they may by Order restrict or prohibit the use of the road or any part thereof by vehicles, or by vehicles of any particular class or description; and restrict or prohibit the use of the footway by pedestrians to such an extent and subject to such conditions or exceptions they may consider necessary.

AND WHEREAS the Hertfordshire County Council are the Highway Authority for the roads and footway hereinafter mentioned which are situated in the Dacorum Borough Council Area within the County of Hertfordshire.

AND WHEREAS 'Manor Estate' development works are proposed to be executed on or near the roads and footway.

AND WHEREAS the Council are satisfied that all vehicular traffic on the roads hereinafter described should by reason of the said work being required and being in progress on the said roads be prohibited and that suitable alternative routes for traffic are available as shown on the diversion plans.

AND WHEREAS the Council are satisfied that the waiting of vehicles on the roads hereinafter described should by reason of the said work being required and being in progress on the said roads be prohibited.

AND WHEREAS the Council are satisfied that all pedestrians using the footway hereinafter described should by reason of the said work being required be prohibited and that suitable alternative routes for pedestrians are available as shown on the diversion plan.

NOW the Council do hereby Order as follows:-

- 1. All traffic is prohibited from using the lengths of roads specified in Schedule 1 to this Order.
- 2. All vehicles are prohibited from waiting at any time on both sides of the lengths of roads specified in Schedule 2 to this Order.
- 3. All pedestrians are prohibited from using the footway situated on the east side of Featherbed Lane, Hemel Hempstead from its junction with Winifred Road south westwards to its junction with King Edward Street, a distance of approximately 102 metres.
- 4. This Order shall come into operation from 7 September 2016 and remain in force for a period of up to eighteen months, when signs are in place.

Schedule 1

King Edward Street, Hemel Hempstead

from its junction with Featherbed Lane south eastwards for a distance of approximately 30 metres

Featherbed Lane, Hemel Hempstead

from its junction with Winifred Road south westwards to its junction with King Edward Street, a distance of approximately 145 metres

Featherbed Lane, Hemel Hempstead

from its junction with King Edward Street south westwards for a distance of approximately 100 metres

Schedule 2

Featherbed Lane, Hemel Hempstead

from its junction with A4251 London Road south westwards to its junction with Winifred Road, a distance of approximately 121 metres

Winifred Road, Hemel Hempstead

from its junction with Featherbed Lane southwards and south westwards for a distance of approximately 40 metres
