THE HERTFORDSHIRE (BEGGARS LANE, ALDBURY, TRING) (VERGE PARKING PLACE) ORDER 2016
(AMENDMENT) ORDER 2018

NOTICE is given that the Hertfordshire County Council has made an Order under the Road Traffic Regulation Act 1984 to introduce an amendment The Hertfordshire (Beggars Lane, Aldbury, Tring) (Verge Parking Place) Order 2016 and also insert a revised exception in The Hertfordshire (Beggars Lane, Aldbury, Tring) (Restriction of Waiting) Order 2016. The general effect of this Order will be to extend the existing verge parking provision and amend the exception in the adjacent Waiting Restrictions provisions. The Order will come into effect on Monday 4 February 2019.

Any person wishing to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the date of this Notice apply to the High Court for this purpose.

SCHEDULE: Extension of existing verge parking place – effecting that section of road listed below and as set out in the Order and accompanying plan - Beggars Lane verge parking facility to be extended by 30 metres.

STATEMENT OF REASONS

THE HERTFORDSHIRE (BEGGARS LANE, ALDBURY, TRING) (VERGE PARKING PLACE) ORDER 2016 (AMENDMENT) ORDER 2018

Following a recent review of The Hertfordshire (Beggars Lane, Aldbury, Tring) (Verge Parking Place) Order 2016, it is proposed to extend the existing verge parking provision by a further 30 metres in Beggars Lane, Aldbury, Tring.

Beggars Lane is a popular location for leisure parking for those who wish to use local facilities. However, parking on Beggars Lane is unsuitable due to the lack of carriageway width, with the existing restriction being insufficient with parked vehicles obstructive the two way flow.

There are existing double yellow lines, no waiting at any time restrictions, which are to remain in place. The verge parking will be permitted behind these.

Consultation regarding this amendment is being carried out under the statutory process, as required by The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996.

**THE HERTFORDSHIRE (BEGGARS LANE, ALDBURY, TRING)
(VERGE PARKING PLACE) ORDER 2016 (AMENDMENT) ORDER 2018**

The Hertfordshire County Council in exercise of their powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order may be cited as "The Hertfordshire (Beggars Lane, Aldbury, Tring) (Verge Parking Place) Order 2016 (Amendment) Order 2018" and shall come into effect on Monday 4 February 2019.
2. The Hertfordshire (Beggars Lane, Aldbury, Tring) (Verge Parking Place) Order 2016, herein after referred to as "the 2016 Order" is amended as follows:

The Schedule to "the 2016 Order" is hereby amended so as to read –

Beggars Lane from a point 16 metres south east of a point in line with the projected (south west side) south east kerbline of Station Road south eastwards for 85 metres.

3. The Hertfordshire (Beggars Lane, Aldbury, Tring) (Restriction of Waiting) Order 2016, herein after referred to as "the 2016 Waiting Restriction Order" is amended as follows;


Article 6 to "the 2016 Waiting Restriction Order" is amended so as to read –

The restrictions imposed by this Order shall not apply to those sections of grass-crete parking area in Beggars Lane designated by the provisions of The Hertfordshire (Beggars Lane, Aldbury, Tring) (Verge Parking Place) Order 2016, as amended by The Hertfordshire (Beggars Lane, Aldbury, Tring) (Verge Parking Place) Order 2016 (Amendment) Order 2018

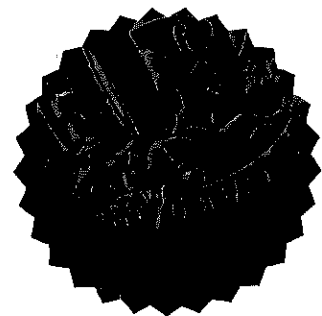
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

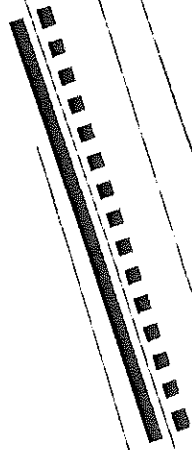
