THE BOROUGH OF DACORUM (BERKHAMSTED) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT NO. 1) ORDER 2020

Dacorum Borough Council, pursuant to arrangements made under section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under sections 1, 2(1), 2(2), 4 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

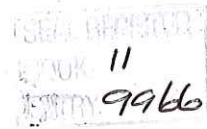
1. This Order may be cited as "The Borough of Dacorum (Berkhamsted) (Prohibition and Restriction of Waiting) (Amendment No. 1) Order 2020" and shall come into operation on 10 May 2021.
2.
 - (1) In this Order "enactment" means any enactment, whether public general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978¹ shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. Without any prejudice to any Act or omission before coming into force of this Order, the Borough of Dacorum (Berkhamsted) (Prohibition and Restriction of Waiting) (Consolidation) Order 2003 shall have effect as though:
 - (a) the item in Schedule 1 to that Order consisting of the text 'Manor Street – South East – From its junction with High Street northeastwards for a distance of approximately 10 metres' in columns 1, 2 and 3 of that Schedule were hereby omitted;
 - (b) there were added to Schedule 2 to that Order the items set out in columns 1, 2 and 3 of Schedule 1 to this Order;
 - (c) the item in Schedule 3 to that Order consisting of the text 'Manor Street – North West – From its junction with High Street northeastwards to a point 10 metres south of its junction with Chapel Street' in columns 1, 2 and 3 of that Schedule were hereby omitted; and
 - (d) there were added to Schedule 3 to that Order the item set out in columns 1, 2 and 3 of Schedule 2 to this Order.

High Street (Berkhampsted)	North East	From its junction with Manor Street southeastwards for a distance of 10 metres
Manor Street	North West	From its junction with High Street (Berkhampsted) northeastwards for a distance of 10 metres
Manor Street	South East	From its junction with High Street (Berkhampsted) northeastwards for a distance of 10 metres

Waiting Restricted

(Waiting Prohibited, Monday to Saturday inclusive, 8.30am to 6.30pm)

Column 1	Column 2	Column 3
STREET NAME	SIDE OF STREET	LOCATION
Manor Street	North West	From a point 10 metres northeast of its junction with High Street (Berkhampsted) northeastwards to a point 10 metres south of its junction with Chapel Street
