THE BOROUGH OF DACORUM (HEMEL HEMPSTEAD) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT NO. 2) ORDER 2020

Dacorum Borough Council, pursuant to arrangements made under section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council, and in exercise of the powers conferred on that County Council under sections 1, 2(1), 2(2) 4 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order may be cited as the Borough of Dacorum (Hemel Hempstead) (Prohibition and Restriction of Waiting) (Amendment No. 2) Order 2020 and shall come into force on 10 May 2021.
2. (1) In this Order:-

"enactment" means any enactment, whether public general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment; and

"the Order of 2003" means the Borough of Dacorum (Hemel Hempstead) (Prohibition and Restriction of Waiting) (Consolidation) Order 2003¹, as amended.
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2003 shall have the same meaning as in that Order.
3. Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2003 shall have effect as though:
 - (a) there were added to Schedule 1 to that Order the items set out in columns 1, 2 and 3 of Schedule 1 to this Order;
 - (b) there were added to Schedule 2 to that Order the items set out in columns 1, 2 and 3 of Schedule 2 to this Order;
 - (c) the items listed as:-

"Hillfield Road / South / From its junction with Marlowes to its junction with Alexandra Road";

"Marlowes / West / From the southern kerb line of the junction with Combe Street southwards for a distance of approximately 15 metres";

"Marlowes / West / From the northern boundary of No. 140 southwards for a distance of approximately 30 metres";

"Marlowes / West / From a point opposite the southern boundary of No. 105 southwards for a distance of approximately 25 metres"; and

"Marlowes / East / From the southern boundary of No. 105 southwards for a distance of approximately 35 metres";

and set out in Schedule 1 to that Order were omitted;

(d) the items listed as:-

"Marlowes / East / From a point 3 metres south of the southern boundary of No. 33 southwards for a distance of approximately 62 metres"; and

"Marlowes / East / From a point 5 metres south of the centreline of Dacorum Way southwards for a distance of 6 metres";

and set out in Schedule 9 to that Order were omitted; and

(e) the item listed as *"Marlowes / On its western side in the layby between No. 140 and 148"* and set out in Schedule 11 to that Order were omitted.

4. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

SCHEDULE 1
Waiting Prohibited At Any Time

1 Street name	2 Side of street	3 Length of street
Hillfield Road	South	Between a point 10 metres east of the eastern kerb-line of Marlowes and its junction with Alexandra Road.
Marlowes	East	Between a point 16 metres north of the common boundary of Nos. 37 and 39-41 Marlowes and a point 9.5 metres south of the common boundary of Nos. 37 and 39-41 Marlowes.

SCHEDULE 2

Waiting, Loading and Unloading Prohibited At Any Time

1 Street name	2 Side of street	3 Length of street
Bridge Street	North	Between its junction with Marlowes and a point 1 metre west of the eastern wall of Nos. 2-6 Bridge Street.
Bridge Street	South	Between its junction with Marlowes and a point 7 metres east of the eastern wall of No. 172 Marlowes.
Hillfield Road	North (westbound carriageway)	Between the western kerb-line of the central reservation located at its junction with Marlowes and a point 3.5 metres east of that kerb-line.
Hillfield Road	South (westbound carriageway)	Between its junction with Marlowes and a point 10 metres east of the eastern kerb-line of Marlowes)
Marlowes	East (southbound carriageway)	Between the northern kerb-line of the central reservation of Hillfield Road at its junction with Marlowes and a point 6 metres south of the southern kerb-line of the westbound carriageway of Hillfield Road.
Marlowes	West (southbound carriageway)	Between the northern kerb-line of the central reservation located to the south of its junction with Hillfield Road and a point 4.5 metres south of that kerb-line.
Marlowes	Central reservation	The north side of the central reservation located to the south of its junction with Hillfield Road.
Marlowes	East	Between a point 7.5 metres south of the northern wall of No. 147 Marlowes and its junction with Bridge Street.
Marlowes	West	Between its junction with Combe Street and a point 14.5 metres south of the southern kerb-line of Combe Street.
Marlowes	West (northbound carriageway)	Between a point 17.5 metres south of the southern wall of No. 148 Marlowes and a point 13 metres north of the northern wall of No. 150 Marlowes.

1 Street name	2 Side of street	3 Length of street
Marlowes	East (northbound carriageway)	Between the northern kerb-line of the central reservation located to the south of its junction with Hillfield Road and a point 5 metres south of that kerb-line.
Marlowes	West	Between a point 9 metres south of the southern wall of No. 170 Marlowes and its junction with Bridge Street.
