Darlington Borough Council in exercise of their powers under Sections 45, 46, 47, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (the "1984 Act"), the Traffic Management Act 2004 ('the 2004 Act') and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following order:-

## PART 1

### GENERAL

1.

- (1) The following Orders are hereby revoked and their provisions insofar as they relate to matters contained in this Order are consolidated in this Order:-
  - (a) Darlington Borough Council (Residents Parking) Consolidation Order 2012;
  - (b) Darlington Borough Council (Residents Parking) Consolidation Order 2012 (Amendment No.1) Order 2012;
  - (c) Darlington Borough Council (Bank Top) Order 2015;
  - (d) Darlington Borough Council (Payment for Waivers) Order 2016;
  - (e) Darlington Borough Council (Residents Parking) Consolidation Order 2012 (Amendment No.2), (Prohibition and Restriction of Waiting and Loading) Consolidation Order 2012 (Amendment No.8) and (On Street Parking Places) Consolidation Order 2012 (Amendment No.2) Order 2016;
  - (f) Darlington Borough Council (Prohibition and Restriction of Waiting and Loading) Consolidation Order 2012 (Amendment No.15), (Residents Parking) Consolidation Order 2012 (Amendment No.3) and (On Street Parking Places) Consolidation Order 2012 (Amendment No.7) Order 2017;
  - (g) Darlington Borough Council (Various Roads) Order 2017 (Amendment One);
  - (h) Darlington Borough Council (Prohibition and Restriction of Waiting and Loading) Consolidation Order 2012 (Amendment No.16), (Residents Parking) Consolidation Order 2012 (Amendment No.4) and (On Street Parking Places) Consolidation Order 2012 (Amendment No.8) Order 2018;
  - (i) Darlington Borough Council (Various Roads) Order 2017 (Amendment Two).

(2) This Order may be cited as the Darlington Borough Council (Residents Parking) Consolidation Order 2019 and will come into operation on the 2<sup>nd</sup> March 2019.

## PART 2

### INTERPRETATION

2. In this Order :-

- (1) "caravan" means any structure designed or adapted for human habitation that is capable of being moved from one place to another;
- (2) "Civil Enforcement Officer" means a person authorised by or on behalf of the Council under Section 76 of the 2004 Act to supervise and enforce the road traffic contraventions for which the Council is the enforcement authority;
- (3) "the Council" means Darlington Borough Council and for the purposes of this Order any person or organisation authorised by the Council to act on its behalf;
- (4) "disabled person's badge" means a badge in the form prescribed by the Disabled Persons (Badge for Motor Vehicles) (England) Regulations 2000 (as amended) issued by a local authority for display on a motor vehicle driven by a disabled person, or used for the carriage of a disabled person and includes a replacement badge issued in accordance with those Regulations;
- (5) "disabled person's vehicle" means a vehicle displaying a disabled person's badge in the relevant position provided that the vehicle immediately before or after the act of parking has been or is about to be driven or used by the person to whom the badge has been issued or, as the case may be, used for carrying of that person as passenger;
- (6) "electronic communications apparatus" has the same meaning as in section 10 of the Communications Act 2003;
- (7) "enforcement authority" means the Council;
- (8) "event day" means any day upon which an event is taking place at the Northern Echo Arena, Neasham Road, Darlington and signs have been placed on or adjacent to the roads at the entry points of the zone announcing that it is an event day;
- (9) "motor cycle" has the same meaning as in Section 136 of the 1984 Act;
- (10) "motor vehicle" has the same meaning as in Section 136 of the 1984 Act;

- (11) “operational times” means the hours and days specified in Part 5 of this Order;
- (12) “parking contravention” has the same meaning assigned to it by Section 73 and Part 1 of Schedule 7 of the 2004 Act;
- (13) “parking place” means that part of road authorised by this Order to be used as a parking place for use by the specified class of vehicle;
- (14) “Parking Place Parking Permits: Terms and Conditions of Use” means the document with that title produced by the Council;
- (15) “passenger vehicle” means a motor vehicle or motor cycle constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the driver;
- (16) “PCSO” means a Police Community Support Officer authorised to carry out traffic duties;
- (17) “Penalty Charge” means a charge set by the Council in accordance with the provisions of Section 77 and Schedule 9 of the 2004 Act and Regulations made thereunder and in accordance with any guidance given by the Secretary of State;
- (18) “Penalty Charge Notice” means a notice issued by a Civil Parking Enforcement Officer pursuant to the provisions of Section 78 of the 2004 Act and Regulations made thereunder;
- (19) “permit” means a permit issued under the provisions of Part 4 of this Order, other than a visitor’s permit;
- (20) “permit expiry date” means the date at which the permit term expires;
- (21) “permit fee” means the fee payable to the Council by a resident upon application for a permit, the permit fees for each zone are as detailed in Part 6 of this Order;
- (22) “permit holder” means a person to whom a permit has been issued;
- (23) “permit term” means the period for which the permit is valid. Permits can be issued for periods of three months, six months or one year at the discretion of the Council;
- (24) “Property Schedules” means the Schedules to this Order numbered 28.01, 28.02, 28.03, 28.04, 28.05, 28.06, 28.07, 28.08, 28.09, 28.10, 28.11, 28.12, 28.13, 28.14, 28.15 and 28.16;
- (25) “qualifying vehicle” means any passenger vehicle for which a resident may apply for a permit under this Order;

- (26) (i) "relevant position" insofar as it relates to the display of a disabled person badge has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
- (ii) "relevant position" insofar as it relates to the display of a permit or visitors' permit means :-
- (a) where a vehicle is fitted with a windscreen and/or dashboard or fascia the permit or visitor's permit is exhibited on the inside of the windscreen, driver's window or on the dashboard or fascia; or
  - (b) in any other case the permit or visitors' permit is exhibited in a conspicuous position on the vehicle so that the front of the permit is clearly legible from the outside of the vehicle;
- (27) "relevant zone" means the zone for which the permit is valid;
- (28) "resident" means any person whose usual domestic residence is at premises specified in the Property Schedules;
- (29) "traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the Act;
- (30) "trailer" has the same meaning as in Section 136 of the 1984 Act;
- (31) "Universal Services Provider" has the same meaning as in the Postal Services Act 2011, as amended;
- (32) "valid permit" means a permit which is still within the permit term and which has not been withdrawn or surrendered, or a visitor's permit;
- (33) "vehicle" means a motor vehicle or motor cycle and in Articles 14, 15, 16 and 17 of this Order shall have the same meaning as in Section 99(5) of the 1984 Act;
- (34) "visitors' permits" means permits issued under the provisions of Article 18(6) of this Order;
- (35) "waiver" means a waiver issued by the Council upon application from any person wishing to park a vehicle in a parking place in connection with any building operation demolition or furniture removal at premises fronting onto the parking place or a tradesman carrying out work at an adjacent property where the vehicle cannot conveniently be used for such purpose in any other part of the road or in another nearby road and upon payment of the waiver fee. The issue of a waiver is at the discretion of the Council. A waiver becomes invalid as soon as the waiver period has expired;

- (36) "waiver fee" means the fee of £5 for each day or part of a day a vehicle is parked in a parking place and is payable to the Council by an applicant for a waiver at the time of application and in advance of the parking of the vehicle. For tradesmen who require a waiver on a regular basis a waiver may be purchased for an extended period of time by payment in advance of £50 for a period of 13 weeks, £90 for a period of 26 weeks or £150 for a period of 52 weeks. The issuing of waivers for these extended periods of time is at the discretion of the Council;
- (37) "waiver period" means the number of days or weeks for which an applicant for a waiver has paid;
- (38) "zone" means a group of parking places for which a permit is valid. Each zone is identified by a letter allocated to it. The zone to which each parking place belongs is detailed in Column 4 of the Zone Schedules;
- (39) "Zone Schedules" means the Schedules to this Order numbered 21.02, 21.18, 21.19, 21.20, 21.21, 21.22, 21.23, 21.24, 21.25, 21.26, 21.27, 21.28, 21.29, 21.30, 21.31 and 21.32

### PART 3

#### OPERATION OF PARKING PLACES

3. Each road or part of road specified in Column 1 of each of the Zone Schedules is hereby designated as a parking place and is authorised to be used by permit holders only for the leaving of vehicles during the operational times subject to the provisions of Articles 4, 12 and 13 of this Order.
4. Nothing in Article 3 of this Order shall for preventing obstruction of the street restrict the power of the Council, by order, on the occasion of any public procession, rejoicing or illumination, or where the street is thronged or liable to be obstructed, to close or partially close the parking place.
5. The limits of each parking place defined in Article 3 shall be indicated on the highway by the Council placing and maintaining thereon the appropriate traffic signs that will indicate the operational times and the specified users of the parking places.
6. Every vehicle left in a parking places defined in Article 3 shall be of the class specified in Column 3 in each of the Zone Schedules and shall wait in such position as is specified in Column 2 of each of the Zone Schedules.
7. Save as provided in Article 13 of this Order no vehicle other than that of the class specified in Column 3 of the Zone Schedules shall be left in the

parking place unless authorised to do so by a police officer in uniform, a PCSO or a Civil Enforcement Officer.

8. No vehicle shall be left in the parking place so as to unreasonably prevent access to any premises adjoining the road by other persons or so as to be a nuisance provided always that a police officer in uniform, PCSO or Civil Enforcement Officer may at any time require the vehicle to be moved if reasonably necessary for the purpose of preventing obstruction.
9. No caravan or trailer shall be left in a parking place if it is not attached to a vehicle;
10. The engine of a passenger vehicle using a parking place shall be stopped as soon as the vehicle is in position in the parking place, and shall not be started except when about to change the position of the vehicle in, or to depart from the parking place.
11. No person shall use a vehicle whilst it is in a parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services or any other persons' skill or service.
12.
  - (1) The Council may suspend the use of a parking place or any part thereof whenever it considers such suspension reasonably necessary.
  - (2) Nothing in paragraph (1) of this Article shall prejudice the power of a police constable, or a person acting under the instructions of the chief officer of police, to suspend a parking place pursuant to section 49(4A) of the 1984 Act.
  - (3) Any of the persons referred to in paragraphs (1) or (2) of this Article suspending the use of the parking place or any part thereof in accordance with the provisions of the said paragraphs shall thereupon place or cause to be placed in or adjacent to that parking place or the part thereof the use of which is suspended a traffic sign indicating that waiting by vehicles is prohibited.
  - (4) In pursuance of paragraphs (1) and (2) of this Article no person shall cause or permit a vehicle to wait in the parking place or any part thereof during such period as there is placed in or adjacent to that parking place or part thereof, as the case may be, a traffic sign indicating that waiting by vehicles is prohibited, PROVIDED THAT nothing in this paragraph shall apply to any vehicle waiting in the parking place with the permission of the person suspending the parking place or part thereof in pursuance of paragraphs (1)

and (2) of this Article, or with the permission of a police officer in uniform or a PCSO.

13. Nothing in Article 7 of this Order shall prohibit any person from causing or permitting any vehicle to wait in the parking place for so long as may be necessary:-
  - (1) to enable a person to board or alight from the vehicle;
  - (2) to enable a person to deliver to or collect from or load or unload goods at any premises fronting onto the parking place;
  - (3) to enable a vehicle if it is in the service of a Universal Services Provider to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000, as amended;
  - (4) to enable a vehicle to be used for Police, ambulance or fire service purposes when used in an emergency;
  - (5) to enable a vehicle to be used for local authority purposes when that use is a statutory duty requiring a vehicle to be present;
  - (6) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond the control of the driver or such waiting as is necessary to prevent an accident;
  - (7) to enable a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation, demolition, window cleaning or furniture removal at premises fronting onto the parking place provided that prior permission has been sought and obtained from the Council and a waiver has been issued by the Council;
  - (8) if a vehicle is being used for the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the highway or the laying, erection, alteration or repair of any sewer or any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus provided that prior permission has been sought and obtained from the Council;
  - (9) to enable a vehicle being used by a legally qualified general medical practitioner or nurse when visiting a patient residing at adjacent premises;
  - (10) if it is a disabled person's vehicle;

- (11) if the vehicle is an official car being used in connection with a wedding or funeral for so long as is necessary to either pick up passengers from premises abutting a parking place or, if the parking place is adjacent to the premises where the funeral or wedding service is taking place, for the duration of the said service;
  - (12) to enable a tradesman to carry out work at an adjacent property if it cannot conveniently park in any other part of the road or in another nearby road provided that prior permission has been sought and obtained from the Council and a waiver has been issued by the Council.
14. Subject to proviso hereto when a vehicle is left in the parking place in contravention of any of the provisions contained in Articles 6, 7 and 8 of this Order a person authorised in that behalf by the Council may remove the vehicle or arrange for it to be removed from the parking place. Provided that when a vehicle is waiting in the parking place in contravention of the provisions of Article 6 of this Order, a person authorised in that behalf by the Council may alter or cause to be altered the position of the vehicle in order that its position shall comply with that provision.
15. A police officer in uniform, PCSO or Civil Enforcement Officer may, in case of any emergency, move or cause to be moved to any place he thinks fit, any vehicle left in the parking place.
16. Any person removing a vehicle or altering its position by virtue of Article 14 of this Order may do so by towing or driving the vehicle or in such manner as he may think necessary to enable him to remove it or alter its position as the case may be.
- 17.
- (1) When a Civil Enforcement Officer removes or makes arrangements for the removal of a vehicle from the parking place by virtue of Article 14 of this Order, he shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle and its contents.
  - (2) Where a vehicle is removed by the Council from a parking place in pursuance of the provisions of this Order there shall be payable to the Council charges pursuant to section 102 of the 1984 Act and the Removal and Disposal of Vehicles Regulations 1986 and the Removal and Disposal of Vehicles (Charges) Regulations 1993 (as amended).

## **PART 4**

### **PERMITS**

18.

- (1) Any resident or in special cases determined by the Council who is the owner or user of a passenger vehicle may apply to the Council for the issue of a permit to facilitate the leaving of that vehicle in a parking place within the relevant zone for the permit term and any such application shall include the particulars and information required by the Council to be supplied and shall be accompanied by the permit fee. The criteria to be used by the Council to determine special cases is contained in the Parking Place Parking Permits: Terms and Conditions of Use;
- (2) The Council may require a permit holder or applicant for a permit to produce to an officer of the Council such further evidence in respect of an application for a permit or duplicate permit as may reasonably be required so as to verify any particulars of information given by the applicant.
- (3) On receipt of an application made under the foregoing provisions of this Article and the permit fee and upon being satisfied that the applicant is :-
  - (i) a resident and user of a qualifying vehicle; or
  - (ii) a special case determined by the Council

the Council may issue to the applicant a permit of the requisite type to facilitate the leaving of a qualifying vehicle in the relevant zone by the owner (or by a resident using the vehicle with the consent of the owner) provided that:-

- (a) subject to the provisions of Article 19 of this Order the Council shall not issue a permit to any person which would be valid for any period during which any other permit issued to that person is or would be valid;
  - (b) the issue of a permit shall not be construed as if any part of the parking place was reserved solely for the use of the permit holder.
- (4) The permit is non-transferrable and in the event of a permit being transferred the Council will have the right to withdraw the same in accordance with Article 19 of this Order unless the Council has given authority to the resident to transfer the permit to another vehicle.
  - (5) Before or on the permit expiry date, if the permit holder requires a permit for a further permit term, the permit holder is required to pay the permit

fee to the Council upon which a new permit can be issued, the start date of which will be the day following the permit expiry date of the permit valid at the time.

- (6) Each domestic residence specified in Schedule 28.09 to this Order shall be supplied with visitors' permits. The visitors' permits shall be issued by the residents of the properties specified in Schedule 28.09 to their visitors for the sole purpose of parking in the roads specified in Schedule 21.02 during the operational times. Before issuing a visitor's permit the resident shall mark it with the vehicle registration number and the date for which it is valid and the permit shall be displayed in the vehicle in the relevant position. The charge for the provision of visitors' permits is £nil.

19.

- (1) A permit holder may surrender a permit to the Council at any time and shall surrender a permit to the Council on the occurrence of any one of the events set out in paragraph (3) of this Article.
- (2)
- (i) The Council may, by notice in writing served on the permit holder at the address given by that person on the application for the permit or at any other address believed to be that person's place of abode, withdraw a permit entirely at its own discretion and the permit holder shall surrender the permit to the Council within 48 hours of the receipt of the aforementioned notice.
  - (ii) a permit shall cease to be valid on the occurrence of any one of the events set out in paragraph (3) of this Article or on the permit expiry date, whichever is the sooner.
- (3) The events referred to in the foregoing provisions of this Article are:-
- (i) the permit holder ceasing to be a resident;
  - (ii) the permit holder ceasing to be the owner or user of the vehicle in respect of which the permit was issued;
  - (iii) the issue of a duplicate permit by the Council under the provisions of Article 21 of this Order;
  - (iv) the withdrawal of such permit by the Council under the provisions of paragraph (2) of this Article or paragraph (4) of Article 18;
  - (v) where a permit is issued to any person upon receipt of a cheque in respect of the permit fee and the cheque is subsequently dishonoured.

- (4) The Council may withdraw the right of residents to issue visitor permits in accordance with Article 18(6) of this Order if there is evidence that any resident is issuing permits to people who are not visiting their property.
20. If the permit is surrendered in accordance with Articles 19(3)(i) or (ii) of this Order then the permit holder will be entitled to a refund of the permit fee proportionate to the number of whole months remaining in the permit term. If the permit is withdrawn in accordance with Article 19(3)(iv) of this Order no benefit shall be deemed to accrue in respect of any unexpired period thereof for the purposes of any subsequent application made by the permit holder for the issue of a permit in respect of any vehicle.
- 21.
- (1) If a permit is mutilated or accidentally defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall surrender it to the Council and the Council, upon receipt of the permit, shall issue a duplicate permit so marked and upon such issue the original permit shall become invalid.
  - (2) If a permit is lost or destroyed the permit holder may apply to the Council for the issue to him of a duplicate permit and the Council, upon being satisfied as to such loss or destruction, shall issue a duplicate permit so marked and upon such issue the permit which it duplicates shall become invalid. A duplicate permit will only be issued upon payment of a charge of £10.
  - (3) The provisions of this Order shall apply to a duplicate permit and an application therefore as if it were a permit, or as the case may be an application therefor.
22. A permit shall be in writing and shall bear the words 'Parking Permit', and shall include the following particulars:-
- (1) the zone in which the parking place is situated and for which the permit is issued and be endorsed with an issue number;
  - (2) the registration mark of the vehicle or as otherwise authorised by the Council in respect of which the permit has been issued;
  - (3) an authentication that the permit has been issued by the Council;
  - (4) the permit expiry date.
23. During the operational times no vehicle shall be left in a parking place unless there is displayed in the relevant position on the vehicle

continuously for the whole period of waiting a valid permit issued in accordance with the provisions of this Order so that all the particulars referred to in Articles 18(6) or 22 of this Order are readily visible from the front or near side of the vehicle provided that a motor cycle for which a permit has been issued is not required to display a permit.

24. When a valid permit has been displayed on a vehicle in accordance with the provisions of Articles 18(6) or 22 of this Order, no person, not being the driver of the vehicle, shall remove the permit from the vehicle unless authorised to do so by the driver of the vehicle.

## PART 5

## PART 7

### MISCELLANEOUS

27. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
28. Unless the context otherwise requires words denoting the singular shall include the plural and vice versa and words denoting the persons shall include either gender, bodies corporate, unincorporated associations and partnerships.
29. Headings of Parts of this Order, headings of Schedules and the contents of the Table of Contents are for information only and do not form part of the Order and are not to be taken into account in its construction or interpretation.
30. Where a parking place in a road (first road) is described as commencing or terminating at a junction with another road (second road) or at a specified distance from a junction with another road (second road) the measurement of the distance described in the Schedules to this Order shall be taken as starting or ending in line with the highway boundary of the second road.

31. A parking place is marked wholly on the carriageway and does not include any footway or verge abutting the carriageway.

## PART 8

### CONTRAVICTION OF RESTRICTIONS


32. Where a vehicle has been left or used in contravention of the provisions of this Order a Penalty Charge shall be incurred, the amount of which will be set by the Council under the provisions of the 2004 Act and the Regulations made thereunder.
33. Where a Penalty Charge is payable a Penalty Charge Notice shall be issued by a Civil Enforcement Officer pursuant to and in accordance with the 2004 Act.
34. The Penalty Charge shall be payable to the Council in such a manner and within such a period as is specified in the Penalty Charge Notice.
35. Where a Penalty Charge Notice has been attached to a vehicle no person not being the driver of the vehicle or duly authorised representative of the Council shall remove the Penalty Charge Notice from the vehicle unless authorised to do so by the driver.
36. The Penalty Charge Notices referred to in Article 33 of this Order shall be written and issued by hand or by the use of a hand-held data capture device and printer as approved by the Council.
37. The particulars detailed in a Penalty Charge Notice may be stored electronically via the hand-held data capture devices referred to in Article 36 of this Order on a central database as approved by the Council. This information may be retrieved at a later date from the central database and produced as a facsimile of the original Penalty Charge Notice. Any such information so produced may be used as evidence that a Penalty Charge Notice was so incurred and may be used in any proceedings taken.
