DARLINGTON BOROUGH COUNCIL ROAD TRAFFIC RESTRICTIONS (AMENDMENT NO.1 PART 2) ORDER 2024

- 1. The Darlington Borough Council (Prohibition and Restriction of Waiting and Loading) Consolidation Order 2019 (as amended) ('the Prohibition and Restriction of Waiting and Loading Order 2019') is amended as follows:
- 1.1 The length of road detailed in Schedule One to this Order is added to Schedule 6.01 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.2 The length of road detailed in Schedule Two to this Order is added to Schedule 7.03 to the Prohibition and Restriction of Waiting and Loading Order 2019

PART 2 DARLINGTON BOROUGH COUNCIL (ON STREET PARKING PLACES) CONSOLIDATION ORDER 2019

- 2. The Darlington Borough Council (On Street Parking Places) Consolidation Order 2019 (as amended) ('the On Street Parking Places Order 2019') is amended as follows:
- 2.1 The length of road detailed in Schedule Three to this Order is added to Schedule 23.01 to the On Street Parking Places Order 2019
- 2.2 The length of road detailed in Schedule Four to this Order is added to Schedule 25.03 to the On Street Parking Places Order 2019
