(2) DARTFORD BOROUGH COUNCIL of Civic Centre Home Gardens Dartford Kent DA1 1DR ("the District Council")

RECITALS


- 1 This supplementary agreement is made pursuant to an Agency Agreement dated 2 October 2000 ("the Agency Agreement") and relating to the enforcement of parking control
- 2 Pursuant to the Agency Agreement the County Council delegated various powers relating to the enforcement of parking control to the District Council
- 3 Clause 5.2 of the Agency Agreement provides for variations to be made to the Agency Agreement
- 4 The Agency Agreement was varied by a Deed of Variation dated 9 June 2009
- 5 The Civil Enforcement of Parking Contraventions Designation Order 2011 came into force on 7 November 2011 and cancelled The Road Traffic (Permitted Parking Area) (County of Kent) (Borough of Dartford) Order 2001.

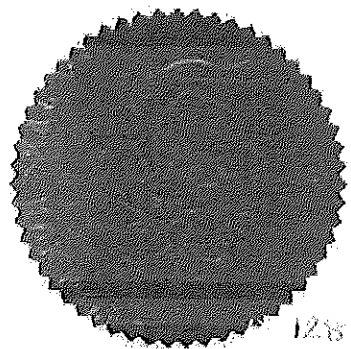
OPERATIVE PROVISIONS

- 1 This deed is entered into pursuant to clause 5.2 of the Agency Agreement and Section 101 of the Local Government Act 1972
- 2 The Agency Agreement and this Deed now take effect by virtue of Section 101 of the Local Government Act 1972, Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 whereby a local authority may arrange for the discharge of its functions by another local authority,
- 3 The County Council and the District Council agree that
 - (i) the area of civil enforcement to be covered by the Agency Agreement is that set out in Schedule 4 of The Civil Enforcement of Parking Contraventions Designation Order 2011
and
 - (ii) all references in the Agency Agreement to the "Designation Order" shall be construed as references to The Civil Enforcement of Parking Contraventions Designation Order 2011
