**ROAD TRAFFIC REGULATION ORDER ACT 1984**

The KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 46, 49 and 53 of the Road Traffic Regulations Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby makes the following Order:-

The Kent County Council (Various Roads, Dartford) (Waiting Restrictions and Street Parking Places) (Consolidation) (Amendment No.12) Order 2012 shall have the effect as though:

**Roads in the District of Dartford**

**No waiting at any time**

The following items to be inserted in the correct alphabetical sequence:

Road	Parish/Town	Length of Restriction
Chastilian Road	Dartford	On the south westerly side from a point 9 metres northeast of its junction with Knole Road to a point 9 metres southwest of its junction with Knole Road
Keary Road	Swanscombe	On the western side from a point 12 metres north of its junction with Munford Drive to a point 12 metres southwest of its junction with Munford Drive
Knole Road	Dartford	On both sides from a point 9 metres south of its junction with Chastilian Road to its junction with Chastilian Road
Lewis Road	Swanscombe and Greenhithe	On the south and western side from a point in line with the shared boundary of properties 10 and 11, in a southerly direction for a distance of 15 metres.
Leyton Cross Road	Wilmington	On the south eastern side from a point 12 metres northeast of its junction with the south western access road to Tredegar Road to a point 12 metres southwest of its junction with the south western access road to Tredegar Road
Maplehurst Close	Wilmington	On both sides from its junction with Pinewood Place in a north westerly direction

Munford Drive	Swanscombe	On both sides from a point 12 metres west of its junction with Keary Road in an easterly direction to its junction with Keary Road.
Norman Road	Dartford	On its southern and western side from a point between Houses No.8 and 10 Norman Road in an easterly then southerly direction for 16 metres.
Oakfield Lane	Wilmington	On both sides from a point 21 metres west of the roundabout junction with Pinewood Place in an easterly direction for a distance of 69 metres.
Pinewood Place	Wilmington	On both sides from its junction with Oakfield Lane to a point 15 metres north of Chaple Walk.
Powder Mill Lane	Dartford	On the north western side, from a point 18 metres south west of the access between buildings 77-78 and 76 to a point 40 metres north east of the access.
The south western access road to Tredegar Road	Wilmington	(i) On the north eastern side from a point 10 metres south of its junction with Leyton Cross Road to its junction with Leyton Cross Road. (ii) On the south western side from a point 12 metres south of its junction with Leyton Cross Road to its junction with Leyton Cross Road.

This Order maybe cited as The Kent County Council (Various Roads, Dartford) (Waiting Restrictions and Street Parking Places) (Consolidation) (Amendment No.12) Order 2012 and shall come into operation on the 3<sup>rd</sup> day of September 2012.
