(VARIOUS ROADS, DARTFORD)
(PROHIBITION OF WAITING)**

CONSOLIDATION (AMENDMENT No. 13) ORDER 2013

ROAD TRAFFIC REGULATION ACT 1984

THE KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under sections 1, 2, 4 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

CITATION AND COMMENCEMENT

This Order may be cited as "The Kent County Council (Various Roads, Dartford) (Prohibition of Waiting) Consolidation (Amendment No. 13) Order 2013" and shall come into operation on the 7th May 2013.

REVOCAION, MODIFICATION AND AMENDMENTS

"The Kent County Council (Various Roads, Dartford) (Prohibition of Waiting) Consolidation Order 2009" be amended as described as follows:-

In **Schedule No. 5.01 No waiting at any time** the following shall be added :-

- (i) Abbey Road, Greenhithe, both sides from its junction with Eynsford Road in a north-easterly direction for a distance of 10 metres.
- (ii) Abbey Road, Greenhithe, both sides from its junction with Alexander Road in a westerly direction for a distance of 10 metres.
- (iii) Alexander Road, Greenhithe, both sides from its junction with Knockhall Road in a south-westerly direction for a distance of 10 metres.
- (iv) Alexander Road, Greenhithe, the west side from a point 10 metres north of its junction with Abbey Road in a southerly direction to a point 10 metres south of its junction with Abbey Road.
- (v) Darenth Road, Dartford, the east side from a point 10 metres south of its junction with Dene Road in a northerly direction to a point 10 metres north of its junction with Dene Road.
- (vi) Dene Road, Dartford, both sides from its junction with Darenth Road in an easterly direction for a distance of 10 metres.
- (vii) Eynsford Road, Greenhithe, the north-east side from a point 10 metres north-west of its junction with Abbey Road in a south-easterly direction to a point 10 metres south-east of its junction with Abbey Road.
- (viii) Joyce Green Lane, Dartford, the east side from its junction with Bob Dunn Way in a northerly direction for a distance of 58 metres.
- (ix) Joyce Green Lane, Dartford, the west side from its junction with Bob Dunn Way in a northerly direction for a distance of 128 metres.

- (x) Knockhall Road, Greenhithe, the north-west side from a point 10 metres north-east of its junction with Alexander Road in a south-westerly direction to a point 10 metres south-west of its junction with Alexander Road.
- (xi) Myrtle Place, Dartford, both sides from its junction with Watling Street in a northerly direction for a distance of 10 metres.
- (xii) Patterdale Road, Dartford, the north-west side from a point 10 metres north-east of its junction with Teesdale Road in a south-westerly direction to a point 10 metres south-west of its junction with Teesdale Road.
- (xiii) Teesdale Road, Dartford, both sides from its junction with Patterdale Road in a westerly direction for a distance of 10 metres.
- (xiv) Watling Street, Dartford, the north side from a point 10 metres west of its junction with Myrtle Place in an easterly direction to a point 10 metres east of its junction with Myrtle Place.

In **Schedule No. 6.16: No Waiting Mon-Fri 8am-9.30am and 2.30pm-4pm** time the following shall be added:-

Lunedale Road, Dartford, the south side from a point 36 metres from the boundary of Nos. 121/123 in a south-westerly direction to a point 34 metres west of its junction with Lunedale Road Link to Nos. 157 to 179.

In **Schedule No. 29.02: No Stopping Mon-Fri 8am-9.30am and 2.30pm-4pm on school entrance markings** the following shall be added:-

- (i) Heath Lane, Dartford, the north-west side from a point 5 metres north-east of a point opposite the boundary of Nos. 51/53 for a distance of 35 metres in a north-easterly direction
- (ii) King Edward Avenue, Dartford, the west side from a point 15 metres north of its junction with Sanctuary Close for a distance of 41 metres in a northerly direction.
- (iii) Littlebrook Manor Way, Dartford, the north-west side from the boundary of Nos. 12/14 in a south-westerly direction for a distance of 31 metres.
- (iv) Lunedale Road, Dartford, the north side from a point 43 metres west of its junction with Swaledale Road for a distance of 23 metres in a westerly direction.
- (v) Lunedale Road, Dartford, the south side from a point 4 metres east of its junction with Lunedale Road Link to No. 157 to 179 in an easterly direction for a distance of 30 metres.
- (vi) Lunedale Road, Dartford, the south-east side from a point 7 metres north-east of boundary of Nos. 121/123 in a south-westerly direction for a distance of 43 metres.
- (vii) Main Road, Longfield, the south side from the western boundary of No. 84 for a distance of 43 metres in a westerly direction.
- (viii) Main Road, Longfield, the south side from a point opposite the boundary of Nos. 191/193 in a westerly direction for a distance of 43 metres.
- (ix) Main Road, Longfield, the south-west side from a point 8 metres south-east of the eastern boundary of No. 241 in a south-easterly direction for a distance of 23 metres.
- (x) Parsons Lane, Wilmington, the north side from the western kerbline of the entrance to Wilmington Grammar School in an easterly direction for a distance of 32 metres.

(xi) St Edmunds Road, Dartford, the south side from a point 10 metres east of Thamesgate in an easterly direction for a distance of 41 metres.

(xii) Swanscombe Street, Swanscombe, the south side from a point 1 metre west of the boundary of Nos. 44/46 for a distance of 33 metres in an easterly direction.

In Schedule No. 5.01 No waiting at any time the following shall be deleted:-

Church Road, Swanscombe

(x) west from a point level with the boundary of Nos. 24/26 southwards to a point level with the boundary of Nos. 42/44


In Schedule No. 29.02: No Stopping Mon-Fri 8am-9.30am and 2.30pm-4pm on school entrance markings the following shall be deleted:-

- (i) Churchill Close, Dartford, south-east from the eastern kerbline of Green Street Green Road to a point 10 metres south-west of the south-western wall of Thistle Court
- (ii) Gorsewood Road, Longfield, north-west from a point 7 metres south-west of its junction with Main Road in a south-westerly direction for a distance of 43 metres
- (iii) Green Street Green Road, Darenth, east from a point 15 metres north of its junction with Churchill Close for a distance of 43 metres in a northerly direction
- (iv) Green Street Green Road, Darenth, west from a point 6 metres south of a point opposite the northern flank wall of Nos. 1 to 8 Trinity Court for a distance of 41 metres in a northerly direction
- (v) Hayes Road, Horns Cross, Greenhithe, south-east from a point 3 metres south-west of the north-eastern boundary of No. 1 for a distance of 27 metres in a north-easterly direction
- (vi) Hayes Road, Horns Cross, Greenhithe, south-east from a point 1 metre south-west of the boundary of Nos. 26/28 for a distance of 26 metres in a south-westerly direction
- (vii) Heath Lane, Dartford, north-west from a point 5 metres north-east of a point opposite the boundary of Nos. 51/53 for a distance of 32 metres in a north-easterly direction
- (viii) King Edward Avenue, Dartford, west from a point 15 metres north of its junction with Sanctuary Close for a distance of 49 metres in a northerly direction
- (ix) Littlebrook Manor Way, Dartford, north-west from a point 7 metres south-west of the boundary of Nos. 13-17/14-18 for a distance of 31 metres in a south-westerly direction
- (x) Lunedale Road, Dartford, north from a point 43 metres west of its junction with Swaledale Road for a distance of 28 metres in a westerly direction
- (xi) Lunedale Road, Dartford, south from a point 23 metres east of its junction with Lunedale Road, access to Nos. 157 to 179 for a distance of 43 metres in an easterly direction
- (xii) Lunedale Road, Dartford, south from a point 66 metres east of its junction with Lunedale Road for a distance of 43 metres in an easterly direction
- (xiii) Main Road, Longfield, south from a point 1 metre east of the boundary of Nos. 125/127 in a westerly direction to a point 1 metre west of the boundary of Nos. 115/117
- (xiv) Main Road, Longfield, south-west from a point 7 metres south-east of the eastern boundary of No. 241 in a south-easterly direction for a distance of 26 metres
- (xv) St Edmunds Road, Dartford, south from a point 23 metres west of the western boundary of Nos. 64/68/72 for a distance of 46 metres in an easterly direction
- (xvi) Stock Lane, Wilmington, east from a point 11 metres north of the northern kerbline of Gerdview Drive in a southerly direction for a distance of 26 metres

(xvii) Swanscombe Street, Swanscombe, south from the boundary of Nos. 44/46 for a distance of 33 metres in an easterly direction
