ROAD TRAFFIC REGULATION ORDER ACT 1984

The KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1) and 124 of the Road Traffic Regulations Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the said Act of 1984, has made the following Order:-

Citation and Commencement



Part 1 - The following items to be revoked from:

THE KENT COUNTY COUNCIL (VARIOUS ROADS, DARTFORD) (PROHIBITION OF WAITING) CONSOLIDATION ORDER 2009

Schedule No. 5.01

No waiting at any time

Bean Road, Greenhithe	On the east side from a point 95 metres south of its truncated junction with London Road to a point level with the boundary of Nos. 1/2 Cobham Terrace
Church Road, Swanscombe	On the west from a point level with the boundary of Nos. 24/26 southwards to a point level with the boundary of Nos. 42/44
Roseberry Gardens, Dartford	On both sides from its junction with Shepherds Lane southwards for a distance of 15 metres measured from the kerb on the south side of Shepherds Lane
Shepherds Lane, Dartford	On the south side from a point 14 metres east of its junction with Roseberry Gardens in a westerly direction to a point 2 metres south-west of a point opposite the western boundary of No. 58 Shepherds Lane.

Anne of Cleves Road, Dartford	i) On the east side from the boundary of house no. 49 to its northern extent and running west along the end of Anne of Cleves Road. ii) On the west side from the boundary of house no. 46 to its northern extent and running north across the entrance to Flanders Court.
Bean Road, Swanscombe	On the north eastern side from the boundary of house nos. 1/2 Cobham Terrace in a north-westerly direction to a point 58 metres south east of its former junction with London Road.
Broomfield Road, Swanscombe	On the south & east side from a point 2 metres east of the boundary of Nos. 77/79 in a westerly then southerly direction for a distance of 24 metres.
Cedar Drive, Sutton at Hone	On both sides from the boundary of house nos. 1 and 2 in a northerly direction to its junction with Devon Road.
Roseberry Gardens, Dartford	Both sides from its junction with Shepherds Lane in a southerly direction for a distance of 24 metres.
Shepherds Lane, Dartford	On the south side from a point 14 metres east of its junction with Roseberry Gardens in a westerly direction to the boundary of Nos. 119/121
