- Priory Hill, Dartford, the south side from the eastern boundary of No. 32 King Edward Avenue in an easterly direction for a distance of 10 metres.

- Littlebrook Manor Way, the northwest side from its junction with Farnol Road in a south-westerly direction for a distance of 15 metres.
- Henderson Drive Dartford, the south-west side from its junction with Farnol Road in a north-westerly direction for a distance of 15 metres.
- Henderson Drive Dartford, the south-west side from its junction with Farnol Road in a south-easterly direction for a distance of 15 metres.
- Denton Road Dartford, both sides from its junction with Rochester Way in a northerly direction for a distance of 15 metres.
- Rochester Way Dartford, both sides from its junction with Denton Road in a westerly direction for a distance of 195 metres.
- St Paul's Close, Dartford, both sides from its junction with Swanscombe Street in an easterly direction for its entire length.

#### Schedule No. 6.01 (No waiting 7am to 7pm)

 St Alban's Road, Dartford, the west side from the southern boundary of No. 14 in a southerly direction for a distance of 19 metres.

#### Schedule No. 6.02 (No waiting Monday to Saturday 8am to 6.30pm)

• Spring Vale, Dartford, the east side from a point 2 metres north of the boundary of Nos. 2/4 in a northerly direction for a distance of 19 metres.
