THE KENT COUNTY COUNCIL (VARIOUS ROADS, DARTFORD) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (CONSOLIDATION) (AMENDMENT No 10) ORDER 2010

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

In the Schedules to the Order

BARN END LANE

The existing item to be deleted in the First schedule and replaced with the following

BARN END LANE

On the eastern side from a point in line with the southern boundary of No 2 New Barn Cottages to a point 10 metres west of the western boundary of No 3 Capel Place.

BAYLY ROAD

The following item to be inserted in the First Schedule in the correct alphabetical sequence

BAYLY ROAD

On the eastern side from a point 10 metres south of the junction with Sundridge Close to a point 10 metres north of that junction.

BIRCHWOOD DRIVE

The following item to be inserted in the First Schedule in the correct alphabetical sequence

BIRCHWOOD DRIVE

On the north eastern side between points 10 metres north west and 10 metres south east of the junction with The Chennies.

CHURCH HILL

The following item to be inserted in the First Schedule in the correct alphabetical sequence

CHURCH HILL

On both sides from a point 18 metres north east of the junction with Curates Walk to a point 18 metres south west of that junction.

CRAYFORD ROAD (A207)

The following item to be inserted in the First Schedule in the correct alphabetical sequence

CRAYFORD ROAD (A207) On both sides from the roundabout with Princes Road to the

District boundary.

CURATES WALK

The following item to be inserted in the First Schedule in the correct alphabetical sequence

CURATES WALK

On both sides from the junction with Church Hill for a distance of 18 metre in a north easterly direction.

DARTFORD ROAD (A266)

The following item to be inserted in the First Schedule in the correct alphabetical sequence

DARTFORD ROAD (A266)

On both sides from the roundabout junction with Princes Road to a point in line with the common boundary of Nos 322 and 324 Dartford Road (A266)

HUMBER ROAD

The following item to be inserted in the First Schedule in the correct alphabetical sequence

HUMBER ROAD

On both sides from the junction with priory Road for a distance of 21 metres in an easterly direction.

NORTH ROAD

The following item to be inserted in the First Schedule in the correct alphabetical sequence

NORTH ROAD

On both sides

- (i) from the junction with Princes Road for a distance of 21 metres in a westerly direction;
- (ii) from a point 21 metre south west of the junction with Waltham Close to a point 21 metres north east of that junction.

PRINCES ROAD

The following item to be inserted in the First Schedule in the correct alphabetical sequence

PRINCES ROAD

On both sides from a point 21 metres south of the junction with North Road to the roundabout at the junction with Dartford Road (A266).

PRIORY ROAD

The following item to be inserted in the First Schedule in the correct alphabetical sequence

PRIORY ROAD

On the eastern side between points 21 metres north and 21 metres south of the junction with Humber Road.

SCHOOL LANE, BEAN

The existing item to be deleted and in the First Schedule and replaced with the following SCHOOL LANE, BEAN

- (1) On the north western side from the junction with Southfleet Road (B255) for a distance of 14 metres in a north easterly direction
- (2) On the south eastern side side from the junction with Southfleet Road (B255) for a distance of 204 metres in a north easterly direction.

SOUTHFLEET ROAD, BEAN (B255)

The existing item to be deleted and in the First Schedule and replaced with the following

SOUTHFLEET ROAD, BEAN (B255)

- (1) On the northern side from a point 65 metres north west of the junction with School Lane to a point 79 metres south east of the junction with School Lane.
- (2) from a point 55 metres north west of the western boundary of the driveway of No 8 Southfleet Road (B255) to a point 79 metres south east of the junction with School Lane.

SUNDRIDGE CLOSE

The following item to be inserted in the First Schedule in the correct alphabetical sequence

SUNDRIDGE CLOSE

On both sides from the junction with Bayly Road for a distance of 10 metres in an easterly direction.

THE CHENIES

The following item to be inserted in the First Schedule in the correct alphabetical sequence

THE CHENIES

On both sides front the junction with Birchwood Road for a distance of 18 metres in a north easterly direction.
