

**THE KENT COUNTY COUNCIL
(VARIOUS ROADS, DARTFORD) (WAITING RESTRICTIONS & STREET PARKING
PLACES) (DARTFORD WEST) (AMENDMENT No. 2) ORDER 2015**

KENT COUNTY COUNCIL, in exercise of its powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 49, and 53 of the Road Traffic Regulation Act 1984 and of all other enabling powers with the consent of the Secretary of State for Transport given under Part II of Schedule 9 of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

CITATION, COMMENCEMENT and REVOCATIONS

1. This Order may be cited as The Kent County Council (Various Roads, Dartford) Waiting Restriction & Street Parking Places) (Dartford West) (Amendment No. 2) Order 2015 and shall come into force on 2nd October, 2015.
2. The Orders titled 'The Kent County Council (Various Roads, Dartford) Waiting Restriction & Street Parking Places) (Dartford West) Order 2011', The Kent County Council (Various Roads, Dartford) (Waiting Restrictions & Street Parking Places) (Greenhithe CPZ) Order 2010, The Kent County Council (Various Roads, Dartford) (Provision of Parking Places) Consolidation Order 2009 and The Kent County Council (Various Roads, Dartford) (Prohibition of Waiting) Consolidation Order 2009 shall be modified or revoked to the extent specified in the Schedules to this Order.
