

**THE KENT COUNTY COUNCIL

KENT COUNTY COUNCIL, in exercise of its powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 49, and 53 of the Road Traffic Regulation Act 1984 and of all other enabling powers with the consent of the Secretary of State for Transport given under Part II of Schedule 9 of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

CITATION, COMMENCEMENT and REVOCATIONS

1. This Order may be cited as The Kent County Council (Various Roads, Dartford) Waiting Restrictions & Street Parking Places (Dartford West) (Amendment No. 3) Order 2016 and shall come into force on 4th April, 2016.

2. The Orders titled 'The Kent County Council (Various Roads, Dartford) (Provision of Parking Places) Consolidation Order 2009' and 'The Kent County Council (Various Roads, Dartford) (Prohibition of Waiting) Consolidation Order 2009' shall be modified to the extent specified in the Schedules to this Order.

Schedule No. 5.01: No waiting at any time

The following are inserted into The Kent County Council (Various Roads, Dartford) (Prohibition of Waiting) Consolidation Order 2009:

Chalice Way, Dartford

- (i) both sides from its junction with Stone Place Road in an easterly direction for a distance of 15 metres.

Church Hill, Dartford

- (i) the east side from its junction with Church Road in a northerly direction to a point 26 metres south of the northern building line of No. 1 Elizabeth Street.
- (ii) the east side from a point 19 metres north of the northern building line of No. 1 Elizabeth Street in a northerly direction to the northern extremity.
- (iii) the west side for its entire length, including the northern extremity.

Elizabeth Street, Dartford

- (i) the north side from its junction with Church Hill in a westerly direction for a distance of 15 metres.
- (ii) the north side from a point 9 metres west of the eastern property wall of No. 29 in a westerly direction to a point in line with the eastern boundary of No. 12 Orchard Terrace.
- (iii) the south side from a point 20 metres west of the eastern property wall of No. 29 in an easterly direction to its junction with Church Hill.
- (iv) the south side from a point 19 metres east of the eastern property wall of No. 12 Orchard Terrace in a westerly direction to a point 14 metres west of the western property wall of No. 2 Orchard Terrace.

Gordon Road, Dartford

- (i) both sides from the boundary of No's 4/6 eastwards, southwards and westwards to a point 5 metres east of the boundary of No's 1/3.
- (ii) the north side from a point 21 metres east of its junction with Highfield Road in an easterly direction to a point 28 metres east of its junction with Highfield Road.
- (iii) the north side from a point 2 metres east of the boundary of No's 64/66 in an easterly direction to its junction with Spring Vale.
- (iv) the north side from its junction with Spring Vale in an easterly direction to a point 6 metres west of the common boundary of No's 60/62.
- (v) the north side from the eastern flank wall of No. 36 in an easterly direction to a point 12 metres east of the eastern flank wall of No. 36.
- (vi) the south side from a point 4 metres east of the common boundary of No's 37/39 in an easterly direction to its junction with North Street.
- (vii) the south side from a point 4 metres west of the boundary of No's 25/27 in a westerly direction to its junction with North Street.

Stone Place Road, Dartford

- (i) the east side from a point 15 metres north of its junction with Chalice Way in a southerly direction to a point 15 metres south of its junction with Chalice Way.
- (ii) the east side from its junction with Church Road in a southerly direction to a point 55 metres north of its junction with Chalice Way.
- (iii) the west side from its junction with Church Hill in a southerly direction to a point 15 metres south of its junction with Chalice Way.

Church Hill, Dartford

- (i) the east side from a point 26 metres south of the northern building line of No. 1 Elizabeth Street to a point 19 metres north of the northern building line of No. 1 Elizabeth Street.

Stone Place Road, Dartford

- (i) the east side from a point 15 metres north of its junction with Chalice Way in a northerly direction to a point 55 metres north of its junction with Chalice Way.
