

**THE KENT COUNTY COUNCIL  
(VARIOUS ROADS, DARTFORD) (WAITING RESTRICTIONS and  
STREET PARKING PLACES) (GREENHITHE CPZ) (AMENDMENT No. 2) ORDER 2012**

The Kent County Council, in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

**PART A**

**General**

**CITATION, COMMENCEMENT and REVOCATIONS**

1. This Order may be cited as The Kent County Council (Various Roads, Dartford) (Waiting Restrictions and Street Parking Places) (Greenhithe CPZ) (Amendment No. 2) Order 2012 and shall come into force on 8<sup>th</sup> November, 2012.
2. The Order titled 'The Kent County Council (Various Roads, Dartford) (Waiting Restrictions and Street Parking Places) (Greenhithe CPZ) Order 2010' shall be modified or revoked to the extent specified in Table 1.

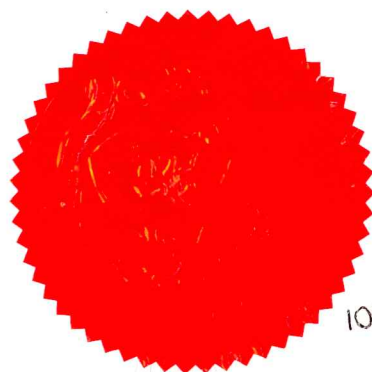
