

**THE KENT COUNTY COUNCIL

KENT COUNTY COUNCIL, in exercise of its powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 49, and 53 of the Road Traffic Regulation Act 1984 and of all other enabling powers with the consent of the Secretary of State for Transport given under Part II of Schedule 9 of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-


CITATION, COMMENCEMENT and REVOCATIONS

1. This Order may be cited as The Kent County Council (Various Roads, Dartford) Waiting Restriction & Street Parking Places) (Dartford West) (Amendment No. 1) Order 2014 and shall come into force on 21st February, 2014.
2. The Order titled 'The Kent County Council (Various Roads, Dartford) Waiting Restriction & Street Parking Places) (Dartford West) Order 2011' shall be modified or revoked to the extent specified in the Schedules to this Order.
3. The Order titled "The Kent County Council (Various Roads, Dartford) (Prohibition of Waiting) Consolidation Order 2009" shall be modified or revoked to the extent specified in the Schedules to this Order.
