

**NOTICE OF PENALTY CHARGES**

**CIVIL ENFORCEMENT AND SPECIAL ENFORCEMENT AREA  
IN THE COUNTY OF DENBIGHSHIRE**

NOTICE is hereby given that Denbighshire County Council in accordance with its powers under Sections 72, 77 and 78 of the Traffic Management Act 2004 and all other enabling powers has set the following penalty charges for parking contraventions within the civil parking of Denbighshire as designated by Road Traffic (Permitted Parking Area and Special Parking Area) (County of Denbighshire) Order 2004/1608.

A two tier system which relates to the seriousness of contravention is being introduced and there will now be higher level and lower level contraventions.

The penalty charges are as set out below:

- (i) a penalty charge of £70 on the issue of a Penalty Charge Notice ("PCN") for higher level contraventions and £50 on the issue of a Penalty charge Notice (PCN) for lower level contraventions in accordance with the provisions of The Civil Enforcement of Parking Contraventions (Guidelines on Level of Charges)(Wales) Order 2008 but discounted by 50% if payment is received within 14 days of the issue of the PCN or within 21 days of the issue of the PCN by post;
- (ii) on the issue of a "Charge Certificate" in accordance with the provisions of The Civil Enforcement of Parking Contraventions (Guidelines on Level of Charges)(Wales) Order 2008 the penalty charge shall be increased by 50%.

The above charges are to take effect on 31<sup>st</sup> March 2008.

- (c) Denbigh Library, Hall Square Denbigh

- (e) Llangollen Library, The Chapel, 19-21 Castle Street, Llangollen.
- (f) Corwen One Stop shop, London Road, Corwen.

RHODDIR RHYBUDD drwy hyn fod Cyngor Sir Ddinbych, yn unol â'i bwerau o dan Adrannau 72, 77 a 78 o Ddeddf Rheoli Traffig 2004 a'r holl bwerau galluogi eraill, wedi pennu'r taliadau cosb canlynol am dramgwyddo rheolau parcio o fewn parcio dinesig yn Sir Ddinbych fel a nodir yn y Gorchymyn Traffig Ffordd (Ardal caniatâd parcio ac ardal parcio arbennig) (Sir Ddinbych) 2004/1608.
