

**DENBIGHSHIRE COUNTY COUNCIL**  
**Road Traffic Regulation Act 1984**  
**(Vale Street, Denbigh)**  
**(Restriction of Waiting) Order 2011**

On 5<sup>th</sup> July 2011 Denbighshire County Council made the above-named Order under Sections 1(1) and (2), 2(1) to (3) and 4(2) and (3) 32, 35, and 124 of the Road Traffic Regulation Act 1984, the effect of which is to prohibit the waiting of vehicles in the length of road specified in the Schedule below.

Exceptions are provided in the Order to permit waiting in the lengths of road referred to in the Schedule for the purposes of alighting, boarding, loading and unloading, and works of maintenance, repair and the like and on the length of road specified in the Schedule.

Exceptions are also be provided in the Order to allow vehicles displaying both a Disabled Person's Badge and a Disabled Person's Parking Disc to wait in the length of road specified in the Schedule of the proposed Order for an unlimited period of time.

The Denbighshire County Council (Prohibition and Restriction of Waiting and Street Parking Places) Consolidation Order 2004 is revoked in so far as it relates to the prohibition and restriction of waiting of vehicles on the length of road referred to in the said Schedule.

A copy of the Order, which will come into operation on the 11<sup>th</sup> July 2011, and a map showing the length of road to which the Order relates may be examined at Denbigh Library, Hall Square Denbigh and at County Hall, Wynnstay Road, Ruthin during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from 5<sup>th</sup> July 2011 apply to the High Court for this purpose.
