Denbighshire County Council (Roads Fronting Rhyl Rail and Bus Station) (Prohibition of Motor Vehicles) And (One Way Traffic) Order 2011.

Denbighshire County Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1) and (2) and 2(1) to (3) and 4(2) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. Save as provided in Article 2 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any motor vehicle other than a bus to enter the lengths of road specified in Schedule 1 hereto
- 2. Nothing in Article 1 of this Order shall apply so as to prevent any person from causing any vehicle to enter the lengths of road specified in the said Schedule 1, if the vehicle is being used:-
 - (a) for the conveyance of persons, goods or merchandise to or from those off street premises situated adjacent to the said lengths of road, and which can be accessed by vehicle only from the said lengths of road;
 - (b) in connection with any building operation or demolition in or adjacent to the said lengths of road, the removal of any obstruction to traffic in the said lengths of road, the maintenance, improvement or reconstruction of the said lengths of road, or the laying, erection, alteration or repair in or adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any line or telecommunications apparatus as defined in the Telecommunications Act 1984.
- 3. No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to proceed along the lengths of road specified in column 1 of Schedule 2 to this Order in a direction other than that specified in column 2 of the said Schedule 2.
- **4.** The Denbighshire County Council (Roads Fronting Rhyl Rail and Bus Station Phase 1) (Traffic Regulation) Order 2001 is hereby revoked in so far as it relates to the lengths of road specified in the Schedules hereto
- **5.** This Order shall come into operation on 11th July 2011 and may be cited as Denbighshire County Council (Roads Fronting Rhyl Rail and Bus Station) (Prohibition of Motor Vehicles) and (One Way Traffic) Order 2011
