

Denbighshire County Council
(Princes Avenue, Prestatyn)
(School Entrance) (Clearway) Order 2014

Denbighshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2) and 124 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART I
CITATION AND INTERPRETATION

1. This Order shall come into operation on the 14th day of April 2014 and may be cited as the Denbighshire County Council (Princes Avenue Prestatyn) (School Entrance) (Clearway) Order 2014

2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"authorised agent" means the parking services contractor appointed by or duly authorised to act on behalf of the Council for the purposes of the supervision and enforcement of this Order;

"authorised officer" means the Head of Highways and Environmental Services for the Council or any other officer of the Council to be designated by the Council;

"carriageway" means a way constituting or comprised in a highway being a way (other than a cycle track) over which the public have a right of way for the passage of vehicles;

"civil enforcement officer" shall have the same meaning as in Section 76 of the Traffic Management Act 2004

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;

"immobilisation device" has the same meaning as in Section 104(9) of the Act of 1984;

"owner", in relation to a vehicle means the person by whom the vehicle is kept. In determining who was the owner of the vehicle at any time it shall be presumed that the owner was the person in whose name the vehicle was at that time registered under the Vehicle Excise and Registration Act 1994;

"the 2002 Regulations" means the Traffic Signs Regulations and General Directions 2002;

"the Act of 1984" means the Road Traffic Regulation Act 1984;

"school entrance area" means any area of carriageway of a specified road, which is comprised within and indicated by a road marking complying with the 2002 regulations

"sign" means a sign of any size, colour and type prescribed or authorised pursuant to or having the effect as though prescribed or authorised pursuant to Section 64 of the Act of 1984.

"specified hours" means the hours between 8 a.m. and 5 p.m. Monday to Friday during school term

"specified roads" means any roads or lengths of roads specified in the Schedule to this Order

"vehicle" has the same meaning as in Section 136 of the Act of 1984;

"zig zag zone" means the sides of lengths of road referred to in the Schedule hereto whereon is marked in yellow paint on the area of carriageway to which the provisions of this order relate

3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

4. The prohibitions imposed by this Order shall be in addition to and not in derogation of any restriction, prohibition or requirement imposed by any Regulations or Orders made or having effect as if made under the Act of 1984, or by or under any other enactment.

5. Save where the contrary is indicated, any reference in this Order to:

(a) this Order or another Order shall be construed as such a reference to this Order or, as the case may be, such other Order, as the same may have been or may from time to time be amended, varied or supplemented;

(b) a Statute or Regulation shall be construed as reference to such Statute or Regulations as the same may have been, or may from time to time be amended or re-enacted.

6. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if for the purposes of Section 21 of that Act this Order were an Act of Parliament

PART II
NO STOPPING ON SCHOOL ENTRANCE MARKINGS

7. No person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, or an authorised agent of the Council cause or permit any vehicle to stop or remain at rest within the zig zag zone on the lengths of roads or sides of the roads referred to in the Schedule hereto during the hours and on the days specified in the said Schedule

PART III
PENALTY CHARGE

8. If a person contravenes any provision(s) of this Order they will be liable to pay a penalty charge

9. The penalty charge shall be paid in the manner specified on the penalty charge notice

From a point 71.6 metres west of the projected kerblines between Princes Avenue and Meliden Road for a distance of 81 metres in a westerly direction

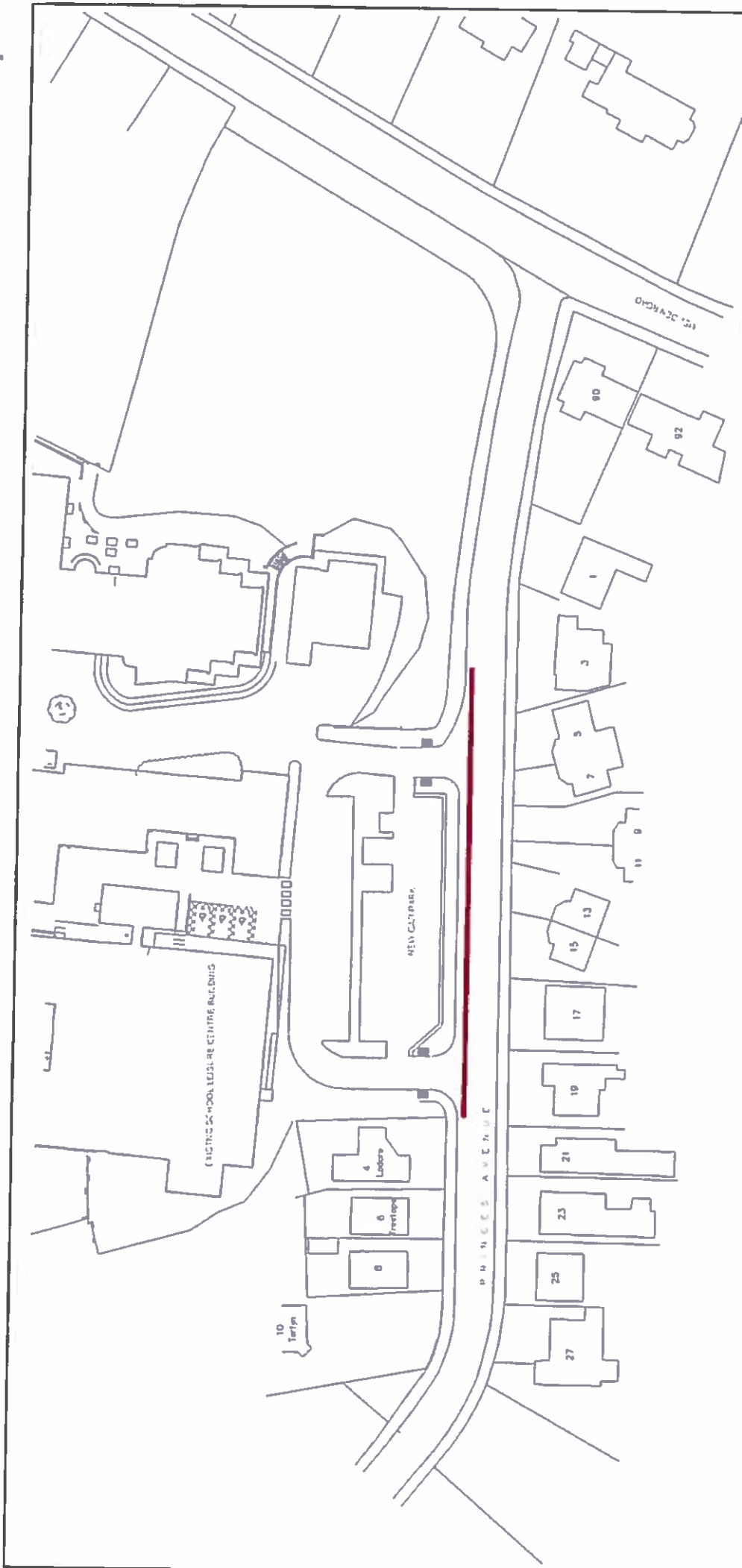
