The Derbyshire County Council ("the Council") in exercise of its powers under Sections 1, 2 and 4 and Part IV of Schedule 9 of The Road Traffic Regulation Act 1984, as amended, ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1 CITATION AND COMMENCEMENT

This Order shall come into force for all purposes on the Fifth day of July Two thousand and Ten and may be cited as "The Derbyshire County Council (Hallowes Lane, Dronfield) (Revocation of Waiting Restrictions) Order 2010".

2 REVOCATION OF WAITING RESTRICTIONS

- 2.1 The existing Limited Waiting restrictions set out in the Schedule to this Order are hereby revoked.
- 2.2 The Bolsover and North East Derbyshire Parking, Waiting and Loading Prohibitions and Restrictions Consolidation Order 2009 is hereby revoked insofar as it relates to the length of road specified in the Schedule to this Order.
- 2.3 The Derbyshire County Council (Various Streets, Dronfield) (Prohibition of Waiting) Order 1973 is hereby revoked insofar as it relates to the length of road specified in this Order.

3 MISCELLANEOUS

3.1 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
