# (REVOCATION OF PROHIBITION OF WAITING) ORDER 2010

The Derbyshire County Council ("the Council") in exercise of its powers under Sections 1, 2 and 4 and Part IV of Schedule 9 of The Road Traffic Regulation Act 1984, as amended, ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

#### 1 CITATION AND COMMENCEMENT

This Order shall come into force for all purposes on the Seventeenth day of May Two thousand and Ten and may be cited as "The Derbyshire County Council (Main Street, Linton) (Revocation of Prohibition of Waiting) Order 2010".

### 2 REVOCATION OF WAITING RESTRICTIONS

- 2.1 The existing No Waiting 8am to 9.15am and 2.45pm to 3.00pm restrictions set out in the Schedule to this Order are hereby revoked.
- 2.2 The Derbyshire County Council (Main Street, Weathernfield and un-named cul-de-sac to rear 0f 106/108 Main Street, Linton) (No Stopping on School Keep Clear and Zig Zag Markings and Waiting Restrictions) Order 2008 is hereby amended insofar as it relates to the length of road within this Order.

### 3 MISCELLANEOUS

3.1 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.




