The Derbyshire County Council ("the Council") in exercise of its powers under Sections 1, 2 and 4 and Part IV of Schedule 9 of The Road Traffic Regulation Act 1984, as amended, ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1 CITATION AND COMMENCEMENT

This Order shall come into force for all purposes on the Twenty-sixth day of September Two Thousand and Eleven and may be cited as "The Derbyshire County Council (Midland Road, Swadlincote) (Revocation of Prohibition of Waiting) Order 2011".

2 REVOCATION OF WAITING RESTRICTIONS

2.1 The existing Limited Waiting 20 minutes, no return within 1 hour, 8am to 6pm, Monday to Saturday restrictions set out in the Schedule to this Order are hereby revoked.

2.2 The Derbyshire County Council (Parking, Waiting and Loading Prohibitions and Restrictions) South Derbyshire Consolidation Order 2009 is hereby amended insofar as it relates to the length of road within this Order.

3 MISCELLANEOUS

3.1 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

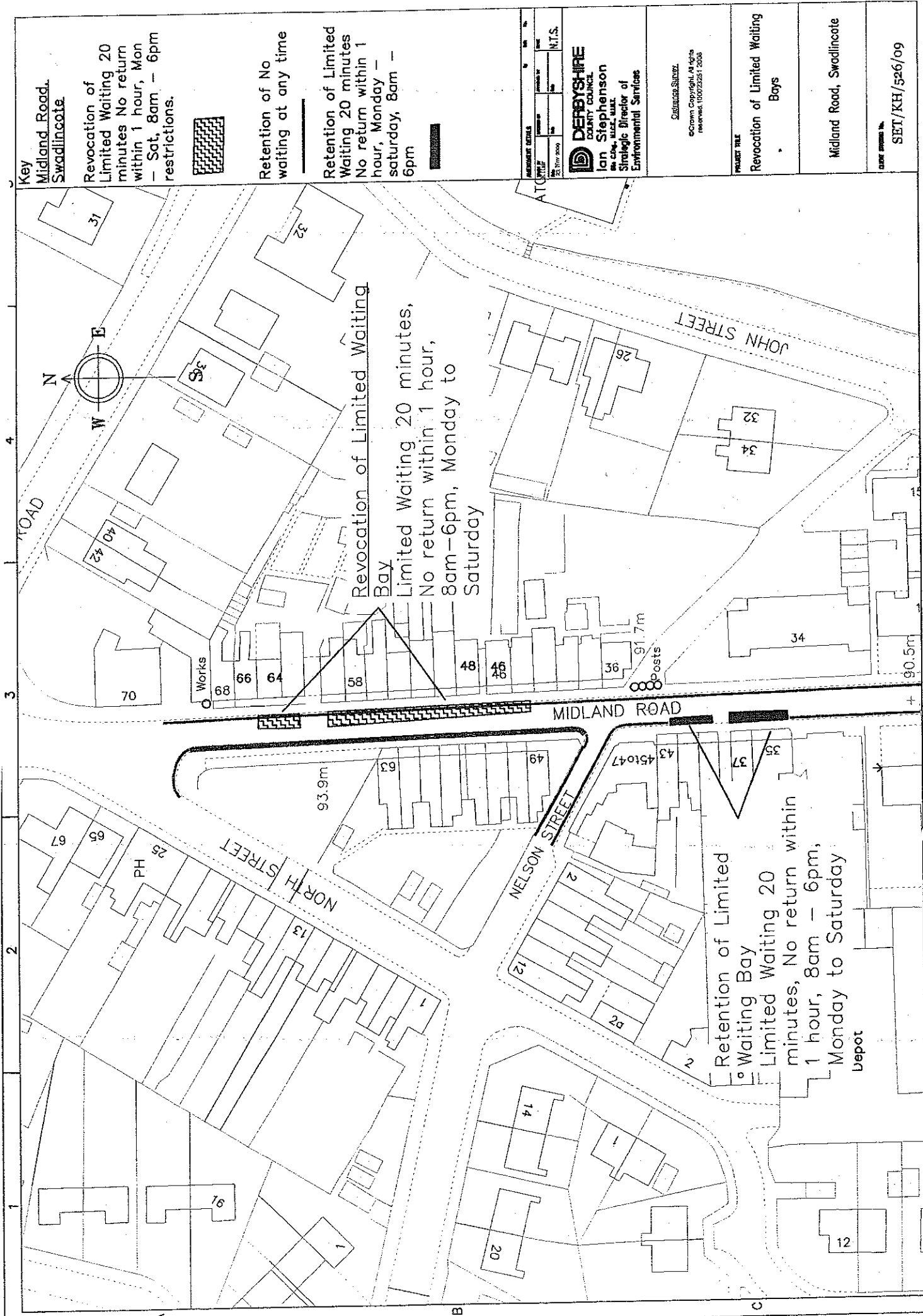
From a point 13 metres north of its junction with Nelson Street in a northerly direction to a point 64 metres north of that junction.

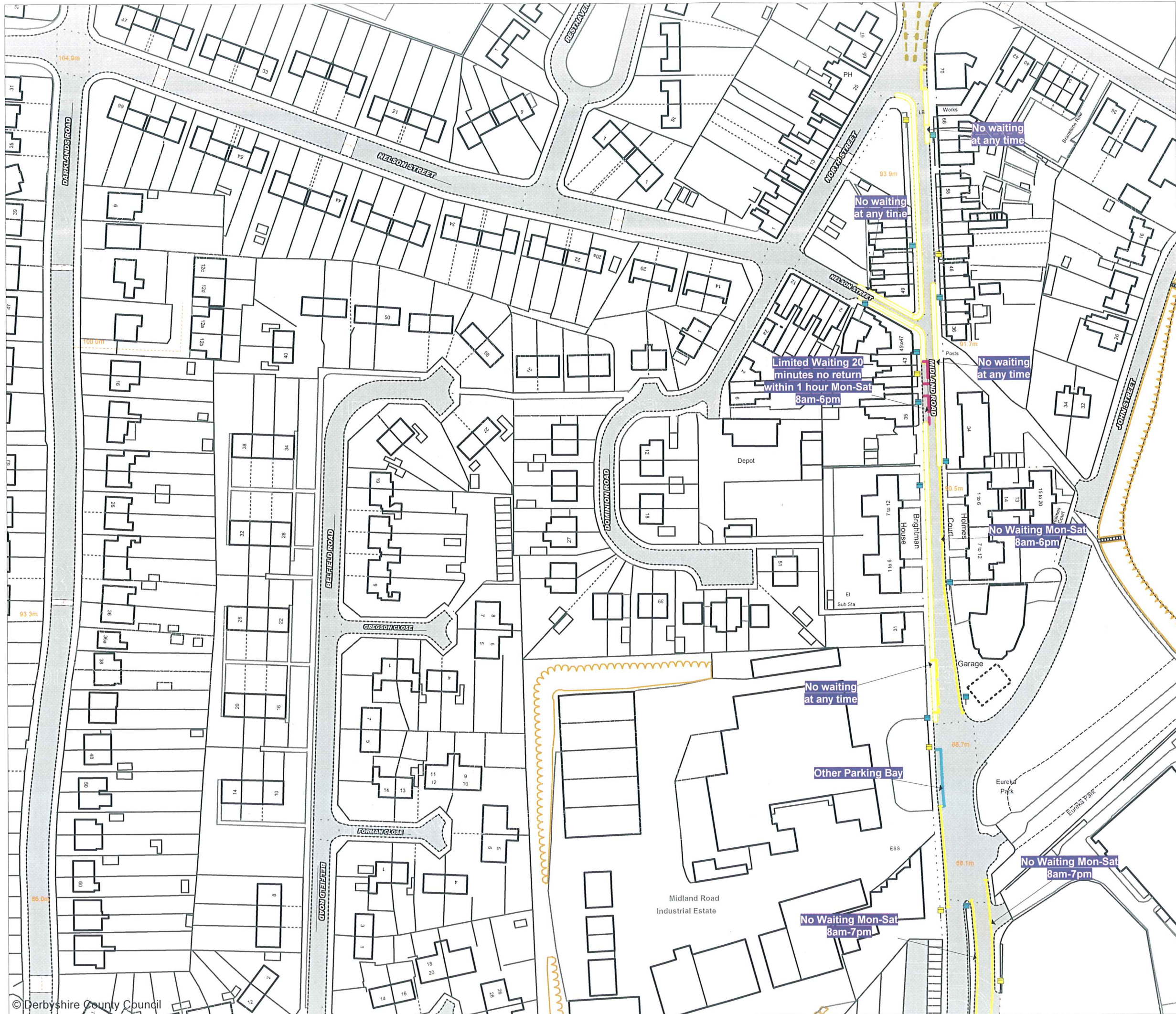
