Derbyshire County Council (hereinafter called "the Council") in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the 1984 Act") and of all other enabling powers, after consultation with the Chief Constable of Derbyshire Constabulary in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

- This Order shall come into operation on the 28th day of April 2016 and may be cited as the Derbyshire County Council (Off-Street Parking Places) (Amendment) Order 2016.
- The Derbyshire County Council (Off-Street Parking Places) Order 2010 is amended as follows:
- 2.1 By adding the following Article 34A to the Order:34A The Council shall have the discretion to charge an applicant for a season ticket at Willington Picnic Site car park a reduced rate where:
 - a) The applicant is a resident of Willington village or is a permanent resident of a canal boat moored between the A5132 road bridge (grid reference 429108 328451) and the railway bridge (grid reference 430062 329010); and
 - b) The applicant has no parking facilities at their property; and
 - c) The applicant is unable to park on the highway within 100 metres of their property due to parking restrictions imposed by way of Traffic Regulation Order under the Road Traffic Regulation Act 1984.
- 2.2 By adding Plan 39 (Willington Station) to the Schedule.

2.3 By adding the following to Part 1 of the Schedule:
