

**Devon County Council (Various Roads, Combe Martin & Ilfracombe)
(Waiting Restrictions) Amendment Order 2017**

Devon County Council make the following order under sections 1, 2, 4 & part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1** This order comes into force on 25th August 2017 and may be cited as “Devon County Council (Various Roads, Combe Martin & Ilfracombe) (Waiting Restrictions) Amendment Order 2017”
- 2** The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

COMBE MARTIN

Schedule 1.001 No Waiting At Any Time

Shackhayes, Combe Martin

the south side from its junction with West Challacombe Lane in a westerly direction for a distance of 1 metre

West Challacombe Lane, Combe Martin

- (i) the north-east side from a point 18 metres south-east of its junction with Five Turnings in a north-westerly then north-easterly direction to a point 49 metres north-west of that junction
- (ii) the north-west side from a point 16 metres north-east of its junction with Shackhayes in a south-westerly direction to a point 30 metres south-east of its junction with Shackhayes

ILFRACOMBE

Schedule 1.001 No Waiting At Any Time

Belmont Road, Ilfracombe

the east side from a point 5 metres north of its junction with Richmond Road in a southerly direction to a point 5 metres south of its junction with Richmond Road

Furze Hill Road, Ilfracombe

the south-west side from a point 29 metres north of the rear boundary of Nos. 2/4 St Brannocks Park Road in a north-westerly direction to its junction with St Brannocks Park Road

Highfield Road, Ilfracombe

- (i) the north side from its junction with Victoria Road in a westerly direction for a distance of 16 metres
- (ii) the north side from a point 124 metres west of its junction with Victoria Road in a westerly direction for a distance of 60 metres
- (iii) the north side from its junction with Castle Hill in a westerly direction to its junction with Cambridge Grove
- (iv) the south side from a point 17 metres west of its junction with Shaftesbury Road in a westerly direction for a distance of 12 metres

Hillsborough Road, Ilfracombe

- (i) the south side from its junction with Castle Hill in an easterly direction for a distance of 103 metres in an easterly direction
- (ii) the south side from a point 144 metres east of its junction with Castle Hill in an easterly direction for a distance of 39 metres in an easterly direction
- (iii) the south side from a point 230 metres east of its junction with Castle Hill in an easterly direction to its junction with Hillsborough Terrace

Horne Road, Ilfracombe

- (i) the east and south side from its junction with St Brannocks Park Road in a southerly direction for a distance of 7 metres
- (ii) the south side from a point 27 metres south of its junction with St Brannock's Park Road for a distance of 62 metres in a westerly direction

Old Berrynarbor Road, Ilfracombe

the south-east side from a point 7 metres south-west of the extended property boundary of 16/17 Watermouth Road in a north-easterly direction to its junction with Watermouth Road

Richmond Avenue, Ilfracombe

both sides from its junction with Richmond Road in a northerly direction for a distance of 3 metres

Richmond Road, Ilfracombe

- (i) both sides from its junction with Station Road in a westerly direction for a distance of 5 metres
- (ii) both sides from its junction with Belmont Road in an easterly direction for a distance of 5 metres
- (iii) the north side from a point 3 metres east of its junction with Richmond Avenue in a westerly direction to a point 3 metres west of its junction with Richmond Avenue

St Brannocks Park Road, Ilfracombe

- (i) the east side from its junction with Windsor Court in a southerly direction for a distance of 4 metres
- (ii) the south-west side from a point 22 metres north-east of the front boundary of Nos. 2/4 St Brannocks Park Road in a north-easterly direction to its junction with Furze Hill Road
- (iii) the west side from its junction with Horne Road in a southerly direction for a distance of 108 metres

Station Road, Ilfracombe

the west side from a point 5 metres north of its junction with Richmond Road in a southerly direction to a point 5 metres south of that junction

Watermouth Road, Ilfracombe

the south-east side from its junction with Old Berrynarbor Road in a north-easterly direction to a point 76 metres north-east of its junction with Corn Mill Close

Wilder Road, Ilfracombe

the west side from a point 67 metres north of its junction with Bradwell Road to its junction with Ilfracombe Footpath 81

Windsor Court, Ilfracombe

the south-east side from its junction with St Brannocks Park Road in a north-easterly direction for a distance of 2 metres

- (i) the north side from its junction with Cambridge Grove in a westerly direction to its junction with Victoria Road
- (ii) the north side from a point 16 metres west of its junction with Victoria Road in a westerly direction for a distance of 108 metres

Hillsborough Road, Ilfracombe

- (i) the south side from a point 103 metres east of its junction with Castle Hill in an easterly direction for a distance of 41 metres in an easterly direction
- (ii) the south side from a point 183 metres east of its junction with Castle Hill in an easterly direction for a distance of 47 metres in an easterly direction

Wilder Road, Ilfracombe

the west side from its junction with Bradwell Road for a distance of 67 metres in a northerly direction

- (i) the north side from its junction with access road to Victoria Road for a distance of 16 metres in a westerly direction
- (ii) the north side from a point 124 metres west of its junction with the access road to Victoria Road for a distance of 60 metres in a westerly direction

Hillsborough Road, Ilfracombe

the south side From its junction with Castle Hill for a distance of 93 metres in an easterly direction

Horne Road, Ilfracombe

the south side from a point 25 metres south of its junction with St Brannock's Park Road for a distance of 64 metres in a westerly direction

West Challacombe Lane, Combe Martin

- (i) the north-east side from its junction with Five Turnings in a northerly direction for a distance of 50 metres
- (ii) the north-east side from a point 10 metres north-west of its junction with Five Turnings to a point 10 metres south-east of its junction with Five Turnings
- (iii) the north-west side from its junction with Shackhayes in a north-easterly direction for a distance of 24 metres in a north-easterly direction
- (iv) the south-west side from its junction with Shackhayes for a distance of 7 metres in a south-easterly direction

Wilder Road, Ilfracombe

the west side from a point 72 metres north of its junction with Bradwell Road for a distance of 8 metres in a northerly direction
