

**Devon County Council (Bishops Court Area, Exeter)  
(Residents Parking Scheme) Amendment Order 2019**

Devon County Council makes the following order under sections 1, 2, 4, 32, 35, 45, 46, 49, 53 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1** This order comes into force 2<sup>nd</sup> May 2019 and may be cited as “Devon County Council (Bishops Court Area, Exeter) (Residents Parking Scheme) Amendment Order 2019”
- 2** The schedules are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended
- 3** The following zone is added to appendix A of Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended

both sides from its junction with Bishops Way for the entire length of the public highway

## Sandy View

both sides from its junction with Bishops Way for the entire length of the public highway

## Woodland Drive

both sides from its northern junction with Bishops Way for the entire length of the public highway to its southern junction with Bishops Way.
