

Devon County Council (Exeter City Centre) (Waiting Restrictions) (Part 4) Amendment Order 2019

Devon County Council makes the following order under sections 1, 2, 4, 32, 35, 45, 46, 49, 53 & part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1** This order comes into force 18th April 2019 and may be cited as “Devon County Council (Exeter City Centre) (Waiting Restrictions) (Part 4) Amendment Order 2019”
- 2** The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended and the lengths of road in part 2 are revoked from the corresponding schedules of that order

PART 1 RESTRICTIONS

Schedule 1.001 No Waiting At Any Time

Bampfylde Street, Exeter

- (i) the north-west side from its junction with Summerland Street in a south-westerly direction to a point 32.5 metres south west of its northern junction with Bude Street
- (ii) the south-east side from its junction with Summerland Street in a south-westerly direction to a point 54 metres south-west of its junction with Cheeke Street

Schedule 2.013 No Waiting 8am-6pm

Bampfylde Street, Exeter

the south-east side from a point 54 metres south-west of its junction with Cheeke Street to a point 30 metres north of its junction with Paris Street

Schedule 3.001 No Loading At Any Time

Bampfylde Street, Exeter

- (i) the north-west side from its junction with Cheeke Street in a south-westerly direction to a point 32.5 metres south west of its northern junction with Bude Street
- (ii) the south-east side from its junction with Summerland Street in a south-westerly direction to a point 54 metres south-west of its junction with Cheeke Street

Schedule 11.030 Local Buses Only At Any Time

Bampfylde Street, Exeter

the north-west side from a point 32.5 metres south-west of its northern junction with Bude Street in a south westerly direction for a distance of 54 metres

Schedule 1.001 No Waiting At Any Time**Bampfylde Street, Exeter**

- (i) the north-west side from its junction with Cheeke Street in a north-easterly direction to its junction with Summerland Street
- (ii) the north-west side from its junction with Cheeke Street for a distance of 11 metres in a south-westerly direction
- (iii) the north-west side from its northern junction with Bude Street to a point 6.5 metres south west of that junction
- (iv) the south-east side from its junction with Summerland Street in a south-westerly direction to its junction with Cheeke Street

Schedule 2.013 No Waiting 8am-6pm**Bampfylde Street, Exeter**

- (i) the north-west side from a point 26 metres south-west of its junction with Cheeke Street to its northern junction with Bude Street
- (ii) the south-east side from its junction with Cheeke Street in a south-west direction to a point 30 metres north of its junction with Paris Street

Schedule 3.001 No Loading At Any Time**Bampfylde Street, Exeter**

- (i) the north-west side from its junction with Cheeke Street to a point 11 metres south west of that junction
- (ii) the north-west side from its northern junction with Bude Street to a point 6.5 metres south-west of that junction
- (iii) the south-east side from its junction with Summerland Street in a south-westerly direction to its junction with Cheeke Street

Schedule 3.010 No Loading 8am-6pm**Bampfylde Street, Exeter**

- (i) the north-west side from a point 26 metres south-west of its junction with Cheeke Street to its northern junction with Bude Street
- (ii) the south-east side from its junction with Cheeke Street to a point 47m south west of that junction

Schedule 8.005 Loading Only 8am-6pm**Bampfylde Street, Exeter**

the north-west side from a point 11 metres south-west of its junction with Cheeke Street to a point 26 metres south-west of that junction
