

**Devon County Council (Denmark Road, Exeter) (Waiting Restrictions)  
Amendment Number 2 Order 2019**

Devon County Council make the following order under sections 1, 2, 4, 32, 35, 45, 46, 49, 53 & part IV of schedule 9 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1 This order comes into force 14<sup>th</sup> June 2019 and may be cited as “Devon County Council (Denmark Road, Exeter) (Waiting Restrictions) Amendment Number 2 Order 2019”
- 2 The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended and the lengths of road in part 2 are revoked from the corresponding schedules the specified orders

**PART 1 RESTRICTIONS**

**Schedule 1.001                    No Waiting At Any Time**

**Denmark Road, Exeter**

- (i) the west side from a point 85.4 metres south of its junction with Barnfield Road in a northerly direction to a point 78 metres south of that junction
- (ii) the west side from a point 98 metres south of its junction with Barnfield Road in a northerly direction to a point 92 metres south of that junction

**Schedule 6.005                    Residents Parking At Any Time Zone E**

**Denmark Road, Exeter**

the west side from a point 108 metres south of its junction with Barnfield Road in a northerly direction to a point 98 metres south of that junction

**Schedule 7.001                    Disabled Badge Holders Only At Any Time**

**Denmark Road, Exeter**

the west side from a point 92 metres south of its junction with Barnfield Road in a northerly direction to a point 85.4 metres south of that junction

the north-west side from a point 78 metres south-west of its junction with Barnfield Road for a distance of 9 metres in a south-westerly direction
