

**DONCASTER BOROUGH COUNCIL
(VARIOUS ROADS DONCASTER)
(PARKING, STOPPING, WAITING AND LOADING CONSOLIDATION)
ORDER 2007
(AMENDMENT NO.11) ORDER 2007**

The Doncaster Borough Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading Consolidation) Order 2007 shall have effect as though the following items were included in Schedule 1.03 of the Order No waiting at any time:-

CLIFTON HILL CONISBROUGH	East Side From a point 45 metres north west of its junction with the north western kerbline of Windmill Avenue in a south easterly direction to a point 39 metres south east of its junction with the south eastern kerbline of Medley View
	West Side From a point 44 metres north west of its junction with the projected north western kerbline of Windmill Avenue in a south easterly direction for a distance of 145 metres
WINDMILL AVENUE CONISBROUGH	Both Sides From its junction with the eastern kerbline of Clifton Hill for a distance of 16 metres in a north easterly direction
MEDLEY VIEW CONISBROUGH	Both Sides From its junction with the eastern kerbline of Clifton Hill for a distance of 10 metres in a north easterly direction
UNNAMED ACCESS ROAD TO TIP ON WEST SIDE OF CLIFTON HILL CONISBROUGH	Both Sides From its junction with the western kerbline of Clifton hill for a distance of 9 metres in a south westerly direction

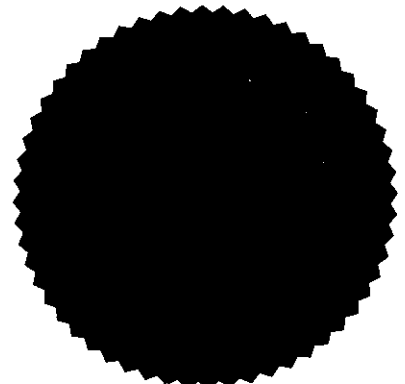
