And the following items were substituted in lieu thereof:-

HIGHFIELD

North West Side

ROAD

From a point 31 metres south west of its junction with the south western kerbline of Queens Road in a north easterly direction to a point 7 metres south west of its junction with the south western kerbline of Baxter Avenue

(b) and the following items were deleted from Schedule 2.02 of the Order No waiting Monday to Saturday between 8.00 a.m. and 6.00 p.m. within Residents Permit Priority Parking Schemes:-

HIGHFIELD ROAD

From its junction with Broxholme Lane to a point 15 metres north east of the north eastern kerbline of Queens Road

And the following items were substituted in lieu thereof:-

HIGHFIELD

North West Side

ROAD

From its junction with Broxholme Lane to a point 7 metres south west of its junction with the south western kerbline of

Baxter Avenue

South East Side

From its junction with Broxholme Lane to a point 15 metres north east of the north eastern kerbline of Queens Road
