

**DONCASTER BOROUGH COUNCIL
(VARIOUS ROADS DONCASTER)
(PARKING, STOPPING, WAITING AND LOADING CONSOLIDATION)
ORDER 2007
(AMENDMENT NO. 30) ORDER 2007**

Doncaster Borough Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading Consolidation) Order 2007 shall have effect as though:-

(i) the following items were deleted from in Schedule 2.08 of the Order No waiting Monday to Friday between 8.00 a.m. and 6.00 p.m. :-

QUEEN MARY	Both Sides
CRESCENT	From a point 15 metres north west of its junction with the north
KIRK SANDALL	western kerbline of Graham Road for a distance of 43 metres in a south easterly direction

And the following items were substituted in lieu thereof:-

QUEEN MARY	North East Side
CRESCENT	From a point 15 metres north west of its junction with the north
KIRK SANDALL	western kerbline of Graham Road for a distance of 47 metres in a south easterly direction

South West Side

From a point 15 metres north west of its junction with the north western kerbline of Graham Road for a distance of 108 metres in a south easterly direction

(ii) and the following items were included in Schedule 2.08 of the Order No waiting Monday to Friday between 8.00 a.m. and 6.00 p.m. :-

GRAHAM ROAD	North Side
KIRK SANDALL	From a point 24 metres north east of its junction with the north eastern kerbline of Dentons Green Lane for a distance of 27 metres in a north easterly direction

2 This Order shall come into operation on the 10th day of March 2008 and may be cited as the "Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading Consolidation) Order 2007 (Amendment No. 36) Order 2008".

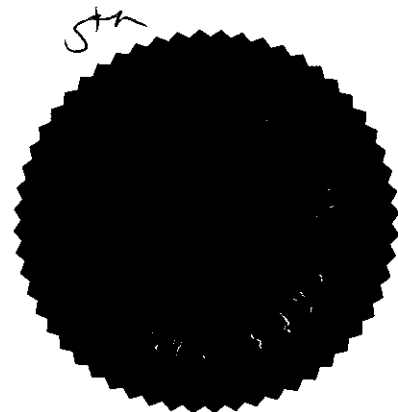

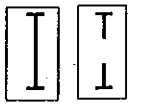
