(xviii) on a Friday between the hours of 9.00 a.m. and 5.00 p.m. on any of the sides of the lengths of road specified in Schedule 2.20 to this Order

(ii) and the following items were deleted from Schedule 2.13 of the Order No waiting Tuesday and Friday between 9.00 a.m. and 5.00 p.m.:-

NELSON ROAD ROSSINGTON

North Side

From a point 15 metres west of its junction with the western kerbline of Queen Mary's Road for a distance of 76 metres in a westerly direction

NORMAN CRESCENT ROSSINGTON

North East Side

- (i) From its junction with the northern kerbline of Norman Crescent in a south easterly direction for a distance of 26 metres including the turning head
- (ii) From the apex of the junction with Queen Mary's Road for a distance of 29 metres in a north westerly direction.

North Side The whole

South West Side The whole

QUEEN MARY'S ROAD ROSSINGTON East Side

From the junction with the southern kerbline of Nelson Road for a distance of 91 metres in a southerly direction.

West Side

From its junction with the north eastern kerbline of Norman Crescent for a distance of 29 metres in a northerly direction.

(iii) and the following items were included in Schedule 2.20 No waiting Friday between 9.00 a.m. and 5.00 p.m.:-

NELSON ROAD ROSSINGTON

North Side

From a point 15 metres west of its junction with the western kerbline of Queen Mary's Road for a distance of 76 metres in a westerly direction

NORMAN CRESCENT ROSSINGTON

North East Side

- (i) From its junction with the northern kerbline of Norman Crescent in a south easterly direction for a distance of 26 metres including the turning head
