

**DONCASTER BOROUGH COUNCIL
(VARIOUS ROADS DONCASTER)
(PARKING, STOPPING, WAITING AND LOADING)(CONSOLIDATION)
ORDER 2008
(AMENDMENT NO. 23) ORDER 2009**

The Doncaster Borough Council (hereinafter called "the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading Consolidation) Order 2008 shall have effect as though:-

(i) the following items were deleted from Schedule 1.03 of the Order no waiting at any time:-

- SANDRINGHAM ROAD** **North West Side**
- (iii) From its junction with the south western kerbline of Ardeen Road for a distance of 7 metres in a south westerly direction.
 - (viii) From its junction with the north eastern kerbline of Dublin Road for a distance of 25 metres in a north easterly direction.
- South East Side**
- (ii) From a point 8 metres north east of a point opposite the north eastern kerbline of Ardeen Road for a distance of 9 metres in a north easterly direction.
 - (vi) From its junction with the north eastern kerbline of Tudor Road north eastwards for a distance of 43 metres.
 - (viii) From a point 5 metres north east of a point opposite the north eastern kerbline of Lakeen Road for a distance of 9 metres in a north easterly direction.

and the following items were substituted in lieu thereof:-

- SANDRINGHAM ROAD** **North West Side**
- (iii) From its junction with the south western kerbline of Ardeen Road for a distance of 4 metres in a south westerly direction.
 - (viii) From its junction with the north eastern kerbline of Dublin Road for a distance of 29 metres in a north easterly direction.

South East Side

- (ii) From a point 10 metres north east of a point opposite the north eastern kerbline of Ardeen Road for a distance of 6 metres in a north easterly direction.

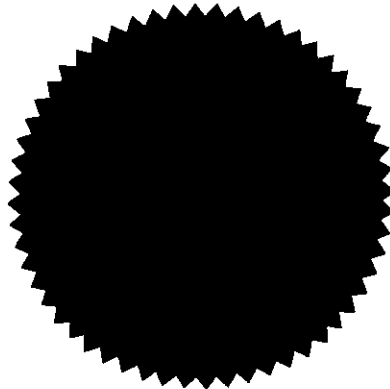
- (vi) From its junction with the north eastern kerbline of Tudor Road north eastwards for a distance of 48 metres.

- (viii) From a point 9 metres north east of a point opposite the north eastern kerbline of Lakeen Road for a distance of 7 metres in a north easterly direction
