

**DONCASTER BOROUGH COUNCIL
(VARIOUS ROADS DONCASTER)
(PARKING, STOPPING, WAITING AND LOADING)(CONSOLIDATION)
ORDER 2008
(AMENDMENT NO. 26) ORDER 2009**

The Doncaster Borough Council (hereinafter called "the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading Consolidation) Order 2008 shall have effect as though:-

(i) there were deleted from Schedule 1.03 of the Order No Waiting at any time the following items:-

GLENFIELD AVENUE	North Side From its junction with the north eastern kerbline of Glenfield Avenue for a distance of 10 metres in a north westerly direction
	North East Side From its junction with the northern kerbline of Glenfield Avenue for a distance of 10 metres in a north easterly direction

And the following items were substituted in lieu thereof:-

GLENFIELD AVENUE	North Side From its junction with the north eastern kerbline of Glenfield Avenue for a distance of 10 metres in a north easterly direction
	North East Side From its junction with the northern kerbline of Glenfield Avenue for a distance of 10 metres in a north westerly direction

(ii) and there were deleted from Schedule 3.10 of the Order No Stopping on school keep clear markings 8.00 am to 9.30 am and 3.00 pm to 4.30 pm Monday to Friday inclusive the following items:-

HIRST GATE MEXBOROUGH	East Side From a point 41 metres north of its junction with the northern kerbline of Doncaster Road for a distance of 26 metres in a northerly direction
NEW PARK ESTATE ROAD STAINFORTH	Western Leg West Side From a point 22 metres north of its junction with the northern kerbline of Thorne Road for a distance of 51 metres in a northerly direction
OWSTON ROAD CARCROFT	West Side From a point 45 metres south of its junction with the southern kerbline of rear service road to Borrowdale Road for a distance of 87 metres in a southerly direction
VICTORIA ROAD EDLINGTON	North Side From a point 29 metres west of its junction with the western kerbline of Staveley Street for a distance of 32 metres in an easterly direction

And the following items were substituted in lieu thereof:-

HIRST GATE East Side
MEXBOROUGH From a point 41 metres north of its junction with the projected northern kerbline of Cross Gate for a distance of 26 metres in a northerly direction

OWSTON ROAD West Side
CARCROFT From a point 45 metres south of its junction with the southern kerbline of rear service road to Borrowdale Close for a distance of 87 metres in a southerly direction

VICTORIA ROAD North Side
EDLINGTON From a point 29 metres west of its junction with the western kerbline of Staveley Street for a distance of 32 metres in a westerly direction

(iii) And there were included in Schedule 3.10 of the Order No Stopping on school keep clear markings 8.00 am to 9.30 am and 3.00 pm to 4.30 pm Monday to Monday to Friday inclusive the following items:

STEVENS ROAD East Side
From a point 52 metres north west of its junction with the northern kerbline of Littlemoor Lane for a distance of 38 metres in a northerly direction

(iv) And there were included in Schedule 14. 02 of the Order No Stopping except buses between 7.00 a.m. and 7.00 p.m. the following items:-

NEW PARK ESTATE Western Leg West Side
ROAD From a point 24 metres north of its junction with the northern kerbline
STAINFORTH of Thorne Road for a distance of 39 metres in a northerly direction

2 This Order shall come into operation on the Sixth day of April 2009 and be cited as "The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading Consolidation) Order 2008 (Amendment No.26) Order 2009.
