

**DONCASTER BOROUGH COUNCIL  
(VARIOUS ROADS DONCASTER)  
(PARKING, STOPPING, WAITING AND LOADING)(CONSOLIDATION)  
ORDER 2008  
(AMENDMENT NO. 3\ ) ORDER 2009**

The Doncaster Borough Council (hereinafter called "the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading Consolidation) Order 2008 shall have effect as though:-

(i) the following items were deleted from Schedule 1.03 of the Order no waiting at any time:-

**ARMTHORPE ROAD North and North West Side**

- (i) From a point 106 metres south west of its junction with the south western kerblines of Sunningdale Road for a distance of 39 metres in a north easterly direction
- (ii) From a point 40 metres south west of its junction with the south western kerblines of Sunningdale Road for a distance of 20 metres in a north easterly direction
- (iii) From a point 9 metres south west of its junction with the south western kerblines of Sunningdale Road for a distance of 25 metres in a north easterly direction
- (iv) From a point 7 metres south west of its junction with the south western kerblines of Hillcrest Road for a distance of 238 metres in a south westerly direction
- (v) From its junction with the south eastern kerblines of Thorne Road for a distance of 51 metres in an easterly direction

**South and South East Side**

- (i) From its junction with the south eastern kerblines of Thorne Road for a distance of 57 metres in an easterly direction
- (ii) From a point 77 metres east of its junction with the south eastern kerblines of Thorne Road for a distance of 22 metres in an easterly direction

- (iii) From a point 55 metres north east of its junction with the north eastern kerbline of Bruce Crescent for a distance of 306 metres in a south westerly direction
- (v) From a point 74 metres south east of its junction with the south eastern kerbline of Thorne Road for a distance of 34 metres in an easterly direction
- (vi) From a point 60 metres south west of its junction with the projected south western kerbline of Sunningdale Road for a distance of 24 metres in a north easterly direction
- (vii) From a point 8 metres south west of its junction with the projected south western kerbline of Sunningdale Road for a distance of 28 metres in a north easterly direction
- (viii) From a point 108 metres north east of its junction with the projected north eastern kerbline of Sunningdale Road for a distance of 31 metres in a north easterly direction

And the following items were substituted in lieu thereof:-

ARMTHORPE ROAD North and North West Side

- (i) From a point 7 metres north east of its junction with the north eastern kerbline of Sunningdale Road for a distance of 24 metres in a south westerly direction
- (ii) From a point 25 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 11 metres in a south westerly direction
- (iii) From a point 73 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 28 metres in a north easterly direction
- (iv) From a point 171 metres south west of its junction with the south western kerbline of Sunningdale Road in a generally westerly direction to its junction with the south eastern kerbline of Thorne Road
- (v) From a point 178 metres north east of its junction with the north eastern kerbline of Sunningdale Road for a distance of 243 metres in a north easterly direction

South and South East Side

- (i) From a point 56 metres north east of its junction with the north eastern kerbline of Bruce Crescent for a distance of 312 metres in a south westerly direction
- (ii) From a point 312 metres south west of its junction with the south western kerbline of Bruce Crescent for a distance of 30 metres in a south westerly direction
- (iii) From a point 436 metres south west of its junction with the south western kerbline of Bruce Crescent for a distance of 78 metres in a south westerly direction
- (iv) From a point 625 metres south west of its junction with the south western kerbline of Bruce Crescent for a distance of 13 metres in a south westerly direction
- (v) From a point 662 metres west of its junction with the south western kerbline of Bruce Crescent in a generally westerly direction to its junction with the south eastern kerbline of Thorne Road

(ii) and the following items were deleted from Schedule 4.05 of the Order Waiting Limited to 30 minutes with no return within 3 hours on any day:-

ARMTHORPE ROAD North East Side

From a point 40 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 15 metres in a south westerly direction.

(iii) and the following items were deleted from Schedule 4.18 of the Order Waiting limited to 3 hours with return prohibited within 4 hours on any day:-

ARMTHORPE ROAD North and North West Side

- (i) From a point 20 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 13 metres in a south westerly direction
- (ii) From a point 10 metres north east of its junction with the north eastern kerbline of Sunningdale Road for a distance of 167 metres in a north easterly direction
- (iii) From a point 70 metres east of its junction with the south eastern kerbline of Thorne Road for a distance of 66 metres in an easterly direction

South and South East Side

- (i) From a point 100 metres east of its junction with the south eastern kerbline of Thorne Road for a

distance of 108 metres in an easterly direction

- (ii) From a point 14 metres north east of its junction with the north eastern kerbline of Sunningdale Road for a distance of 94 metres in a north easterly direction
- (iii) From a point 138 metres north east of its junction with the north eastern kerbline of Sunningdale Road for a distance of 60 metres in a north easterly direction
- (iv) From a point 58 metres east of its junction with the south eastern kerbline of Thorne Road for a distance of 20 metres in an easterly direction

And the following items were substituted in lieu thereof:-

ARMTHORPE ROAD North and North West Side

- (i) From a point 7 metres north east of its junction with the north eastern kerbline of Sunningdale Road for a distance of 171 metres in a north easterly direction
- (ii) From a point 12 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 13 metres in a south westerly direction
- (iii) From a point 36 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 37 metres in a generally westerly direction

South and South East Side

- (i) From a point 252 metres south west of its junction with the south western kerbline of Bruce Crescent for a distance of 60 metres in a south westerly direction
- (ii) From a point 342 metres south west of its junction with the south western kerbline of Bruce Crescent for a distance of 94 metres in a south westerly direction
- (iii) From a point 514 metres south west of its junction with the south western kerbline of Bruce Crescent for a distance of 111 metres in a generally westerly direction
- (iv) From a point 636 metres south west of its junction with the south western kerbline of Bruce Crescent for a distance of 27 metres in a westerly direction

(iv) and the following items were included in Schedule 4.18 of the Order Waiting limited to 3 hours with return prohibited within 4 hours on any day:-

ARMTHORPE ROAD North and North West Side

- (iv) From a point 101 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 70 metres in a generally westerly direction

(v) and the following items were deleted from Schedule 11.01 of the Order Parking Places for Ambulances:-

ARMTHORPE ROAD North East Side From a point 55 metres south west of its junction with the south western kerbline of Sunningdale Road for a distance of 9 metres in a south westerly direction.	Wholly within the bay provided	An ambulance
