Doncaster Borough Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- (i) the following items were deleted from Schedule 1.03 of the Order No Waiting at any time:-

Queen Mary's Road Rossington

West Side

from its junction with the southern kerbline of Nelson Road for a distance of 20 metres in a southerly direction

West End Lane Rossington

South Side

from a point 17 metres east of its junction with the eastern kerbline of Bevan Avenue for a distance of 151 metres in a westerly direction

(ii) and the following items were deleted from Schedule 2.20 No waiting on a Friday 9am to 5pm

Nelson Road Rossington

North Side

From a point 15 metres west of its junction with the western kerbline of Queen Mary's Road for a distance of 76 metres in a westerly direction

Norman Crescent Rossington

North Side The whole

North East side

- (i) From its junction with the northern kerbline of Norman Crescent in a south easterly direction for a distance of 26 metres including the turning head
- (ii) From the apex of the junction with Queen Mary's Road for a distance of 29 metres in a north westerly direction

South West side The whole

Queen Mary's Road Rossington

East Side

From the junction with the southern kerbline of Nelson Road for a distance of 91 metres in a southerly direction

West Side

From its junction with the north eastern kerbline of Norman Crescent for adistance of 29 metres in a northerly direction

(iii) and the following items were included in Schedule 1.03 of the Order No Waiting at any time:-

Norman Crescent Rossington

North Side

From its junction with the northern kerbline of Norman Crescent in a south easterly direction for a distance of 26 metres including the turning head

Queen Mary's Road Rossington

West Side

From a point 20 metres south of its junction with the southern kerbline of Nelson Road for a distance of 40 metres in a northerly direction

West End Lane Rossington

South Side

From a point 21 metres east of its junction with the eastern kerbline of Bevan Avenue for a distance of 151 metres in a westerly direction

(iv) and the following items were included in Schedule 2.03 of the Order No Waiting Monday to Saturday 8am to 6pm:-

Nelson Road Rossington

North Side

From a point 15 metres west of its junction with the western kerbline of Queen Mary's Road for a distance of 61 metres in a westerly direction


