

**THE DONCASTER BOROUGH COUNCIL
(CHAMBER ROAD) (OFF STREET PARKING PLACE)
ORDER 2012**

Doncaster Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and all other enabling powers hereby makes the following Order: -

1. This Order shall come into operation on the 10th day of December 2012 and may be cited as the Doncaster Borough Council (Chamber Road) (Off-Street Parking Place) Order 2012

2. (1) Any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference in this Order to "the Schedule" is a reference to the Schedules to this Order

2 (2) In this Order: -

"1984 Act" means the Road Traffic Regulation Act 1984

"2004 Act" means the Traffic Management Act 2004

"Article" means an Article of the Order unless otherwise stated and includes reference to any paragraph of that Article referred to by number or letter

"Bank Holiday" means a day which is or is observed as a bank holiday or a holiday under the Banking and Financial Dealings Act 1971 or any statutory re-enactment or modification for the time being in force

"charging hours" means any period specified in column 5 of the First Schedule to this Order in respect of which a charge is specified in Article 6

"Civil Enforcement Officer" means a person employed by the Doncaster Borough Council for the purposes of the enforcement (inter alia) of this Order;

"Official User Permit" means a permit issued by the Parking Services Manager to either a person employed by the Council or a visitor to the Council's Civic building to be displayed in a vehicle for the duration of the vehicle's stay in the Chamber Road Car Park

"coach" means a motor vehicle as defined by the Traffic Signs and General Directions 2002

"Council" means the Doncaster Metropolitan Borough Council

"disabled persons badge" as defined by the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000

"disabled persons vehicle" has the same meaning as in the Local Authority Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986

"driver" in relation to a vehicle waiting in a parking place means the person driving the vehicle at the time it was left in the parking place or the person deemed to be the driver under the terms of this Order

"Large Goods Vehicle" means a motor vehicle constructed or adapted for use for the carriage of goods or burden of any description with an operating weight that exceeds 7.5 tonnes

"invalid carriage" has the same meaning as defined by The Use of Invalid Carriages on Highways Regulations 1988 and used within the terms of those Regulations

"official user parking bay" means an area of parking place numbered 1 – 30 which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place

"owner" in relation to a vehicle means the person by whom such vehicle is kept and used

"paragraph" means a paragraph or sub-paragraph of the Article in which the word appears

"parking bay" means any area of a parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place

"parking place" means any area of land specified by name in column 1 of the First Schedule to this Order provided by the Council under Section 32(1) of the 1984 Act for use as a parking place

"Parking Services Manager" means an Officer for the time being appointed to that post by the Council

"Penalty Charge" means a charge set by the Parking Authority in accordance with guidance given by the Secretary of State under the provisions of the 2004 Act and specified in the Penalty Charge Notice

"Penalty Charge Notice" means a Notice issued by a Civil

Enforcement Officer pursuant to the provisions of the 2004 Act

"Relevant position" means:

- (a) In the case of a vehicle fitted with a front windscreen the badge is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen
- (b) In the case of a vehicle not fitted with a front windscreen the badge is exhibited in a conspicuous position on the front or nearside of the vehicle

"Secretary of State" means the Secretary of State for Transport

"Schedule" means a schedule of this Order unless otherwise stated

"Specified Parking charge" is defined in Article 6 of this Order

"ticket machine" for the purpose of this Order means an apparatus designed to issue parking tickets indicating the payment of a charge and the date and time at which the charge was paid

"Uniform" in relation to the 2004 Act means a mode of dress worn by a Civil Enforcement Officer as determined and supplied by the Parking Authority provided that such mode of dress shall at all times clearly identify that the wearer is engaged on parking enforcement duties for the Council and includes the personal identification number of the Civil Enforcement Officer

"Valid Ticket" " means a Ticket which has not become invalid and is not being used in circumstances where it is not valid

- 2 (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament

USE OF LAND AND PARKING PLACE

- 3 (1) Each area of land specified by name in column 1 of the First Schedule to this Order may be used subject to the following provisions of this Order as a parking place for such classes of vehicles in such positions on such days and during such hours as are specified in relation to that area in that Schedule
- 3 (2) Where in the Schedule to this Order a parking place is described as available for vehicles of a specified class or in a specified position the driver of a vehicle shall not permit it to wait in that parking place unless it is of the class and in the position so

specified

- 3 (3) Where within a parking place there is a sign or surface marking which indicates that a parking bay is available only for a disabled person's vehicle the driver of a vehicle shall not permit it to wait in that parking bay unless it is a disabled person's vehicle displaying a current disabled person's badge
- 3 (4) Where within a parking place there is a sign or surface marking which indicates that a parking bay is available only for an Official User Permit Holder's vehicle the driver of a vehicle shall not permit it to wait in that parking bay unless it is a Official User Permit Holder's vehicle displaying a current Official User Permit
- 3 (5) The driver of a vehicle shall not permit it to wait in a parking place for longer than the maximum period permitted for waiting specified in Article 6 of this Order
- 3 (6) When a vehicle has left a parking place after waiting therein the driver thereof shall not within two hours after its leaving permit it to wait again in that parking place
- 3 (7) Insofar as a vehicle is left in a parking place during the charging hours the driver thereof shall pay such charge or charges as are specified in the following provisions of this Order
- 3 (8) Any vehicle displaying an expired ticket shall not be left in a parking place
- 3 (9) Any person who wilfully avoids or seeks to avoid or assists in avoiding the payment of the specified parking charge at the parking place shall be guilty of an offence under Section 35A of the Act

EXEMPTIONS TO PAYMENT OF SPECIFIED PARKING CHARGES

- 4 (1) Without prejudice to Article 5(2) of this Order the driver of a disabled persons vehicle which displays in a relevant position a disabled persons badge shall be exempt from any payment specified in Article 6(1) of this Order subject to the provisions of Article 20 of this Order
- 4 (2) A vehicle belonging to the emergency services when on operational duties which is left in a parking place during the charging hours shall be exempt from any payment specified in Article 6(1) to this Order
- 4 (3) A vehicle displaying a valid official user permit which is left in the parking place displaying a valid official user permit which is left in

the parking place while the driver undertakes duties in relation to his/her employment by the Council or while a visitor to the Council's Civic Building conducts and concludes the purpose of his/her visit

CIRCUMSTANCES IN WHICH A PENALTY CHARGE WILL BE PAYABLE

- 5 (1) If a vehicle is left in a parking place during the operational hours either:-
- (i) without a valid official user permit being displayed
 - (ii) if a vehicle other than a disabled persons vehicle displaying a disabled persons badge in the relevant position is parked in a parking bay marked as available only for a disabled persons vehicle
 - (iii) returning within two hours of leaving the same parking place in contravention of Article 3(6) of this Order
 - (iv) if the vehicle is left in a parking place other than wholly within a marked parking bay
 - (v) if the vehicle is an large goods vehicle
 - (vi) if the vehicle is left in a official user parking bay without a valid official user permit being displayed
- 5 (2) If a disabled persons vehicle displaying a disabled persons badge in the relevant position is left in a parking place other than in a marked disabled parking bay then a penalty charge shall be payable by the driver of the disabled persons vehicle

OFFICIAL USER PERMIT

5. (3) The owner of a vehicle may on application to the Parking Services Manager apply for a official user permit in respect of that vehicle such permit shall be displayed in a conspicuous position on the vehicle in respect of which it is issued
5. (4) Any official user permit applied for under the provisions of Article 5(3) above will only be valid when the vehicle is left in a parking bay on the Chamber Road Car Park
5. (5) The Council may by notice in writing served on the official user permit holder withdraw any official user permit if the Council considers it appropriate to do so on the expiry of one month from the date of the notice

5. (6) The Parking Services Manager may require an applicant for a official user permit to produce to an officer of the Council such evidence in respect of the application as may reasonably be required to verify any particulars or information given
- (i) The official user permit may be surrendered to the Council at any time and must be surrendered to the Council on the occurrence of any of the events set out in paragraph (iii) of this Article
 - (ii) The Council may by notice in writing served on the official user permit holder at the address shown by that person on the application for the official user permit or at any other address considered appropriate by the Council withdraw a official user permit if it appears to the Council that any of the events set out in paragraph (iii) of this Article has occurred and the official user permit shall be surrendered to the Council within 48 hours of the receipt of the said notice
 - (iii) the events referred to in the foregoing provisions of this Article are:-
 - (a) The official user permit holder causing or permitting the official user permit to be used for reward
 - (b) if in the opinion of the Council the use of the official user permit is being abused
 - (c) the issue of a duplicate official user permit by the Council under the provisions of Article 12(i) or (ii) of this Order
 - (d) The official user permit holder terminating his/her employment with the Council
 - (iv) A official user permit shall cease to be valid on the occurrence of any of the events set out in paragraph (iii) above
- 5 (7)
- (i) If a official user permit is mutilated or defaced or the particulars on it have become illegible or it has become altered by fading or otherwise the official user permit holder shall surrender it to the Council and may then apply to the Council for the issue of a duplicate official user permit
 - (ii) If a official user permit is lost or destroyed the holder may apply to the Council for the issue of a duplicate official user permit

- (iii) The provisions of this Order shall apply to a duplicate official user permit and an application for such official user permit as if it were a official user permit or as the case may be an application for a official user permit
- (iv) The issue of a duplicate official user permit by virtue of the provisions of paragraph (i) or (ii) of this Article shall render the original official user permit invalid

AMOUNT OF SPECIFIED PARKING CHARGE AT PARKING PLACES

6. (1) The specified parking charge for a vehicle left in a parking place during the charging hours shall be: -

Chamber	£1.00 pence for a period not exceeding 1 hour
Road	£2.00 pence for a period exceeding 1 hour but not exceeding 2 hours
Car Park	£8.00 pence for a period exceeding 2 hours but not exceeding 10 hours

- 6 (2) The specified parking charge referred to in paragraph (1) of this Article shall be payable by the insertion of the appropriate coinage into the ticket machine provided for such purpose
- 6 (3) When a vehicle is left in a parking place the driver on parking shall purchase and attach in a conspicuous position a ticket for the value of the specified parking charge fixed by this Order for the period the vehicle remains in the parking place and shall keep the ticket in position until leaving the parking place. The ticket shall not be valid unless such ticket is so displayed and kept
- 6 (4) The ticket issued at this car park is not transferable between car parks or vehicles

PENALTY CHARGE AND PAYMENT

- 7 (1) In the case of a vehicle in respect of which a Penalty Charge is payable under the provisions of Article 5, 18 and 19 of this Order a Penalty Charge Notice may be issued by a Civil Enforcement Officer in accordance with the requirements of the 2004 Act
- 7 (2) A Penalty Charge Notice shall contain the details required by the 2004 Act
- 7 (3) Where a Penalty Charge Notice has been issued the Penalty Charge shall be payable by the owner of the vehicle in respect of which the

Notice was issued in accordance with the 2004 Act

- 7 (4) The Penalty Charge shall be paid to the Council in the manner specified in the Notice referred to in Article 7(1) of this Order

RESTRICTION OF REMOVAL OF NOTICES

8 When a Notice has been attached to a vehicle in accordance with any of the foregoing provisions of this Order no person other than a person authorised by the Council in that behalf or the driver or a person authorised by the driver in that behalf shall remove the Notice from the vehicle

OTHER PROVISIONS

9 Pursuant to powers given for the purpose in Sections 35(A) and 47(4) and (6) of the 1984 Act the following shall apply:-

- (a) if on the date a vehicle is left in a parking place a person is shown to have been the Registered Owner or Keeper thereof in writing from the Vehicle Registration Authority then for the purpose of this Order and any legal proceedings in relation thereto it shall be conclusively presumed (notwithstanding that such a person may not be an individual) that he was the driver of the vehicle at that time and accordingly that acts or omissions of the driver of the vehicle at that time were his acts or omissions unless the Registered Keeper can prove that at the relevant time the vehicle was in the possession of some other person without his consent or that he was not the owner of the vehicle
- (b) the date and time printed on any ticket from a ticket machine at a parking place shall be good evidence in any legal proceedings in relation to this Order that the ticket was purchased on that date and at that time
- (c) where in any legal proceedings in relation to the failure to pay any charge under this Order it is proved to the satisfaction of the Court that the amount which has become due or any part thereof has not been paid the Court shall order the payment of the sum not paid which shall then become recoverable as a penalty

10. The driver of a vehicle shall not permit that vehicle to wait in a parking place unless the vehicle is licensed in pursuance of the provisions of the Vehicle Excise and Registration Act 1994 and unless there is in relation to the use of the vehicle by the driver such a policy of insurance as complies with the requirements of Part VI of the Road Traffic Act 1988

11. The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place

- 12 (1) No person shall use a vehicle while it is in a parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services
- 12 (2) No person shall use any part of a parking place or any vehicle left in a parking place -
- (a) for sleeping or camping or cooking or
 - (b) for the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place
13. The driver of a vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in or to depart from the parking place
- 14 (1) If a vehicle is left in a parking place in a position other than in accordance with the provisions of Article 3 of this Order a person authorised by the Council in that behalf may alter or cause to be altered the position of the vehicle so that its position is in accordance with the said provisions
- 14 (2) If a vehicle is left in a parking place in contravention of any of the foregoing provisions of this Order a person authorised by the Council in that behalf may remove the vehicle from that parking place or arrange for such removal
- 14 (3) For the purpose of meeting the requirements of an emergency a person authorised in that behalf by the Council or a police constable in uniform may alter or cause to be altered the position of a vehicle in a parking place or remove or arrange for the removal of a vehicle from a parking place
- 14 (4) Any person altering or causing the alteration of the position of a vehicle by virtue of paragraph (1) of this Article or removing or causing the removal of a vehicle by virtue of paragraphs (2) and (3) of this Article may do so by towing or driving the vehicle or in such other manner as he may think reasonably necessary to enable the position of the vehicle to be altered or the vehicle to be removed
- 14 (5) Any person removing or arranging for the removal of a vehicle by virtue of paragraphs (2) and (3) of this Article shall make such arrangements as he considers to be reasonably necessary for the safety of the vehicle in the place to which it is removed
- 15 Where in a parking place signs are erected or surface markings are laid for the purpose of: -

- (a) . indicating the entrance to or exit from the parking place or
- (b) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place

No person shall drive or permit to be driven any vehicle (i) so that it enters the parking place otherwise than by an entrance or leaves the parking place otherwise than by an exit so indicated or (ii) in a direction other than so specified

16 No person shall except with the permission of a person authorised by the Council in that behalf drive or permit to be driven any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place

17 (1) Where in the parking place signs are erected or surface markings are laid for the purpose of indicating disabled bays the driver of a vehicle which is displaying a current disabled person's badge shall park in a bay and will be exempt from any payment specified in Articles 6 and 7 of this Order

17 (2) Where in the parking place signs are erected or surface markings are laid for the purpose of indicating official user bays the driver of a vehicle which is displaying a current official user permit shall park in a bay and will be exempt from any payment specified in Articles 6 and 7 of this Order

18 A disabled persons vehicle which is parked in a parking bay other than in a marked disabled parking bay shall not be exempt from any payment specified in Articles 6 and 7 of this Order.

19 A Official User Permit Holder's vehicle which is parked in a parking bay other than in a marked official user bay shall be exempt from any payment specified in Articles 6 and 7 of this Order.

20 Where in the parking place signs are erected or surface markings are laid for the purpose of indicating motor cycle bays the rider of a motor cycle shall park in one of the bays provided for a maximum length of stay specified in Article 6 of this Order for that car park and be exempt from any payments in the bays provided specified in Articles 6 and 7 of this Order

21 No vehicle shall be left in a parking place other than in a position indicated by a sign or by white lines on the surface of the parking place and in particular no vehicle shall be left in a parking place in such a position so as to obstruct the entrance thereto or the exit there from nor in such a position so as to prevent the driving away of any vehicle already in a parking place or in such a position so as to cause an obstruction to other vehicles

22 The Council may suspend the operation of this Order on any day when any area of land specified in column 1 of the First Schedule to this Order is

required in connection with any official function or business of the Council or on account of any security reasons or for any other purpose whatsoever

23 No person shall in the parking place wantonly shout or otherwise make any loud noise to the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood

24 No person shall in a parking place use threatening abusive or insulting language gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned

DISPOSAL OF VEHICLES ON PARKING PLACES

25 Pursuant to powers given for the purpose in Sections 99 and 101 of the 1984 Act the Council may sell or otherwise dispose of any vehicle that has been or could at any time be removed from a parking place in pursuance of Article 14 of this Order

Provided that the power of disposal conferred by this Article shall not be exercisable unless the Council has taken such of the following steps as are applicable to the vehicle and there has elapsed a period of six weeks beginning with the taking of the first of those steps

- 26 (1) Subject to the provisions of Article 31 of this Order where a vehicle carries a registration mark issued under the Vehicle Excise and Registration Act 1994 the Council shall ascertain in writing from the Vehicle Registration Authority the name and address of the person who it appears is the owner of that vehicle
- 26 (2) For the purposes of Articles 24 and 26 the first steps shall be taken to be the sending of the notice mentioned in Article 26

27 The Council shall send by recorded delivery service a notice to the address of the person who by virtue of Article 26 of this Order it appears is the owner of the vehicle stating that it is the intention of the Council to sell or otherwise dispose of the vehicle (which shall be sufficiently described in the notice) on or after the specified date (which shall not be less than two weeks from the date of the notice and in any event not earlier than six weeks from the date of the first step taken by the Council under this Part of this Order) unless it is in the meantime removed by or on behalf of that person from such place as may be specified by the Council in the said notice or from such other place as may be subsequently notified in writing by the Council to that person

28 If any person to whom a notice is sent in accordance with Article 27 of this Order informs the Council of the name and address of some other person who he alleges may be the owner of the vehicle a notice stating the particulars mentioned in Article 27 shall be sent by recorded delivery service to that other person and to any further person who the Council may in consequence of the

sending of the notice to the said other person be led to believe may be the owner of the vehicle

29 Subject to the provisions of Article 32 of this Order where a vehicle does not carry a registration mark issued under the Vehicle Excise and Registration Act 1994 the first step to be taken by the Council shall be to apply in writing to the Chief Officer of the Police Force in whose area is the parking place from which the vehicle has been or could at any time be removed inquiring who that Officer considers is the owner of the vehicle and the address of that person

30 If after steps have been taken under the foregoing provisions of this Part of this Order a vehicle is not claimed the Council shall make such further inquiries (if any) as it considers reasonable as to who may be the owner of the vehicle and the address of that person

31 Where by virtue of Articles 29 and 30 of this Order the Council is informed of the name and address of a person who it considers may be the owner of the vehicle Articles 27 and 28 of this Order as respects the sending of notices shall apply in relation to the person mentioned in the said Article 27

32 Nothing in the foregoing provisions in this Part of the Order shall require the Council to take any such steps as is therein mentioned for the purpose of inquiring who is the owner of a vehicle to which Article 25 of this Order applies if the Council has found a person who it is satisfied is in fact the owner of that vehicle and a notice in the manner and containing the particulars specified in Article 27 of this Order has been sent to him at his address the sending of the notice being treated as the first step for the purposes of that Article and Article 25

33 The Council shall apply the proceeds from any vehicle sold under the provisions of this part of this Order in or towards the satisfaction of any costs incurred in connection with the disposal thereof and of any charge to payment of which the Council is entitled as regards the vehicle under the provisions of the Act

34 In the event of any such costs incurred by the Council in connection with the disposal of the vehicle not being satisfied by virtue of Article 33 of this Order the Council may recoup those costs so far as not satisfied from the person who was the last owner of the vehicle before it was removed from the parking place either in pursuance of Article 14 of this Order or after it has been disposed of by virtue of the power of disposal conferred by Article 25 of this Order except in a case where that person satisfies the Council that he was not responsible for the vehicle being in the place from which it was removed and in that case the person by whom the said cost shall be payable shall be the person driving the vehicle at the time it was left in that place

35 Any sums received by the Council on the sale of the vehicle after deducting any sum applied thereto by virtue of Article 33 of this Order shall be payable to any person who satisfies the Council within a period of one year from the date of the sale of the vehicle that but for such sale the vehicle would

have belonged to him and insofar as any such sums are not claimed within the said period they shall be retained by the Council

RIGHT OF OWNER TO RECOVER VEHICLE OR PROCEEDS FROM SALE OF VEHICLE

- 36 (1) Pursuant to Section 101A of the 1984 Act if before a vehicle is disposed of by the Council pursuant to the provisions of Section 101 of the 1984 Act and under the provisions of Article 24 of this Order it is claimed by a person who;
- (a) satisfies the Council that he is its owner and,
 - (b) pays the relevant charges

the Council shall permit him to remove the vehicle from its custody within such period as the Council may specify

- 36 (2) before the end of the period of one year beginning with the date on which a vehicle is sold by the Council under Section 101 of the 1984 Act a person satisfies the Council that at the time of the sale he was the owner of the vehicle the Council shall pay him any sum by which the proceeds of sale exceed the amount of the relevant charges specified below;

- (a) any penalty charge payable in respect of the parking of the vehicle in the place from which it was removed; or
- (b) such unpaid earlier penalty charges relating to the vehicle as may be prescribed; and
- (c) such sums in respect of the removal and storage of the vehicle as the Council may require in accordance with Section 9 of the 2004 Act

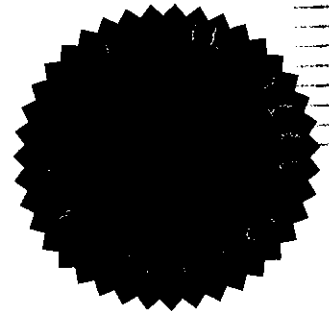
- 36 (3) in any other case the relevant charges are such sums in respect of the removal and storage of the vehicle as may be prescribed

- 36 (4) in the case of any vehicle it appears to the Council that more than one person is or was its owner at the relevant time such one of them as the Council thinks fit shall be treated as its owner for the purposes of this section

37 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under either the 1984 Act or the 2004 Act or by or under any other enactment.

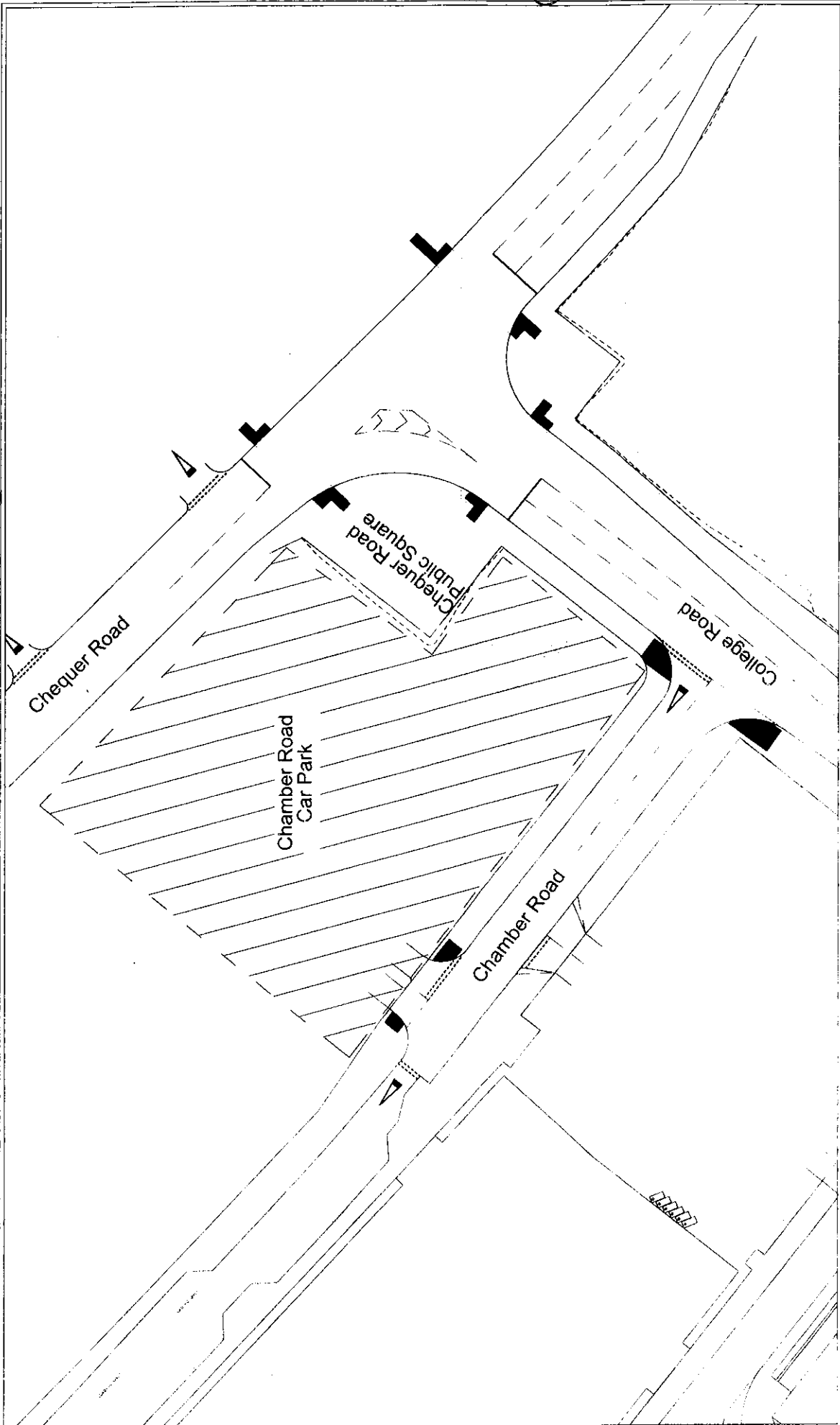
