## DONCASTER BOROUGH COUNCIL (VARIOUS ROADS DONCASTER) (PARKING, STOPPING, WAITING AND LOADING )(CONSOLIDATION) ORDER 2008 (AMENDMENT NO.107) ORDER 2012

Doncaster Borough Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading) (Consolidation) Order 2008 shall have the effect as though:-
- 1.1 the following item was deleted from Schedule 1.01 No waiting at any time (Controlled Parking Zone):-

St George Gate private access road at the rear of Littlewood Stores

from its junction with the north eastern kerbline of St George Gate for a distance of 36 metres in a north easterly direction

and the following items were substituted in lieu thereof:-

St George Gate private access road at the rear of Primark Store

- (i) the north-east side from its junction with Church Way for its entire length.
- (ii) the south side from the boundary of the hotel building line for a distance of 8 metres in a south-westerly direction
- (iii) the south side from a point 10.5 metres from the boundary of the hotel building line for a distance of 6 metres in a south-westerly direction
- (iv) the south side from a point 21.5 metres from the boundary of the hotel building line for a distance of 3.5 metres in a south-westerly direction
- (v) the south side from a point 30 metres from the boundary of the hotel building line for its entire length.
- (vi) the south-east side from a point 33 metres from its junction with the eastern kerb line of St George Gate for a distance of 3 metres in a north-easterly direction
- (vii) the south-east side from its junction with St George Gate for a distance of 17 metres in an north easterly direction

- (viii) the west side from its junction with Church Way for its entire length.
- 1.2 the following item was deleted from Schedule 1.03 No waiting at any time:-

Unnamed Service Road Leading From Church Way To St George Gate

1.3 the following item was deleted from Schedule 5.11 Prohibition of Loading or Unloading Monday to Saturday 8.00 A.M. to 6.00 P.M. within controlled parking zone:-

St George Gate Private Access Road

Both sides

from its junction with the north eastern kerbline of St. George Gate for a distance of 36 metres in a north easterly direction

Unnamed Service Road leading from Church Way to St. George Gate

North Side

from its junction with the northern kerbline of St. George Gate Private Access Road for a distance of 33 metres in a north easterly direction

1.4 the following item was included in Schedule 5.01 Prohibition of Loading or Unloading at any time:-

St George Gate Private Access Road at the rear of Primark Store

South East Side

- (i) from a point 33 metres north east of its junction with the eastern kerb line of St George Gate for a distance of 3 metres in a north-easterly direction
- (ii) from its junction with St George Gate for a distance of 17 metres in an north easterly direction
- the following item was included in Schedule 13.04 Loading and Unloading Bay Monday to Saturday 8.00 am to 6.00 pm within Controlled Parking Zone:-

St George Gate Private Access Road at the rear of Primark Store

## South Side

from a point 8 metres south west of the boundary of the hotel building line for a distance of 2.5 metres in a south-westerly direction

## South East Side

from a point 17 metres north east of its junction with the eastern kerb line of St George Gate in an easterly direction for a distance of 16 metres in a north easterly direction
