

**DONCASTER BOROUGH COUNCIL
(VARIOUS ROADS DONCASTER)
(PARKING, STOPPING, WAITING AND LOADING)(CONSOLIDATION)
ORDER 2008
(AMENDMENT NO.114) ORDER 2013**

Doncaster Borough Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading) (Consolidation) Order 2008 shall have the effect as though:-

(i) the following item was deleted from Schedule 1.01 of the Order No waiting at any time:-

Chequer Road

South West Side

From a point 77 metres north west of its junction with the north western kerblines of Beechfield Road in a north westerly direction to its junction with the south eastern kerblines of Waterdale

and the following item was substituted in lieu thereof:-

Chequer Road

South West Side

From a point 23 metres north west of its junction with the north western kerblines of Beechfield Road in a north westerly direction to its junction with the south eastern kerblines of Waterdale

(ii) and the following items were deleted from Schedule 1.02 of the Order No waiting at any time Residents Permit Priority Parking Schemes:-

Chequer Road

South West Side

From a point 28 metres north west of its junction with the north western kerblines of Beechfield Road for a distance of 14 metres in a north westerly direction.

Rainton Road

North Side

From a point 19 metres north east of its junction with the north eastern kerblines of Ravensworth Road in a north easterly direction for a distance of 4 metres

(iii) and the following items were deleted from Schedule 8.02 of the Order lengths of road specified as a parking bay within the Beechfield Residents Permit Priority Parking Scheme:-
