

**DONCASTER BOROUGH COUNCIL  
(VARIOUS ROADS DONCASTER)  
(PARKING, STOPPING, WAITING AND LOADING)(CONSOLIDATION)  
ORDER 2008  
(AMENDMENT NO. 117) ORDER 2013**

Doncaster Borough Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading) (Consolidation) Order 2008 shall have the effect as though:-

(i) The following item was deleted from Schedule 8.10 of the order list of addresses eligible for Residents Parking Permits - Doncaster

Copley Road                      - (a) the north west side  
   - (b) the south east side from Christ Church Road to Broxholme Lane

And the following item was substituted in lieu thereof:-

Copley Road                      The whole

(ii) and the following item was inserted into Schedule 8.10 of the order list of addresses eligible for Residents Parking Permits - Doncaster

Thorne Road                      Numbers 1 to 95 (odd numbers only)

(iii) and the following definition was inserted into Part 1 - Definitions - of the order

"Cashless Parking" means a method of payment by which the driver of the vehicle on arrival at the parking place registers the vehicle by contacting the Parking Services Manager by mobile phone or similar device to supply sufficient information regarding the details of the location of the parking place; the time of arrival at the parking place and the registration details of the vehicle to be recorded to allow the vehicle to park within the parking place in compliance with the provisions of this Order

(iv) and the following article was deleted from Part IV - Controlled Parking Zone - of the Order

10. (4) (b) The charge referred to in paragraph (a) of this Article shall be payable on the leaving of the vehicle in the parking place by the insertion of the appropriate coinage into the ticket machine

And the following article was substituted in lieu thereof

10. (4) (b) The charge referred to in paragraph (a) of this Article shall be payable on the leaving of the vehicle in the parking place either under the cashless parking provisions by registering the details of the vehicle with the parking manager or by the insertion of the appropriate coinage into the ticket machine provided for such purpose

3 This Order shall come into operation on the 4<sup>th</sup> day of November 2013 and may be cited as the "Doncaster Borough Council (Various Roads Doncaster) (Parking Stopping Waiting and Loading) (Consolidation) Order 2008 (Amendment No.117) Order 2013".
