THE DONCASTER BOROUGH COUNCIL (CHAMBER ROAD) (OFF STREET PARKING PLACE) ORDER 2012 (AMENDMENT NO. 2) ORDER 2016

Doncaster Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and all other enabling powers hereby makes the following Order: -

- 1 The Doncaster Borough Council (Chamber Road) (off street parking place) Order 2012 shall have effect as though:-
- (i) the following items were included in article 2 (2) of the Order:-

"Electric Vehicle" means a Plug-in Electric Vehicle or a Plug-in Hybrid Electric Vehicle

"Electric Vehicle Parking Bay" means any area of a parking place that is provided for the use of drivers of Electric Vehicles in order to recharge their vehicle by using the electric plug-in points in the car park and is indicated by blue lines, symbols and or signage located within the boundaries of the parking place".

"Electric Vehicle Charging Point" means a purpose built unit designed specifically for the charging of electric vehicles.

(ii) and the following item was inserted as article 3(10) of the Order:-

Where within a parking place there is a sign or surface marking which indicates that a parking bay is available only for use by an electric vehicle the driver of a vehicle shall not permit it to wait in that parking bay unless it is an electric vehicle and the vehicle is being recharged at the electric vehicle charging point contained within that parking bay

(iii) and the following item was inserted as article 4(4) of the Order:-

Without prejudice to Article 5(3) of this Order an Electric Vehicle left in an Electric Vehicle Parking Bay shall be exempt from any payment specified in Article 6(1) of this Order subject to the provisions of Article 19(2) of this Order.

(iv) and the following item was deleted from article 4(1) of the Order:-

Without prejudice to Article 5(2) of this Order the driver of a disabled persons vehicle which displays in a relevant position a disabled persons badge shall be exempt from any payment specified in Article 6(1) of this Order subject to the provisions of Article 20 of this Order

and the following item was substituted in lieu thereof:-

Without prejudice to Article 5(2) of this Order the driver of a disabled persons vehicle which displays in a relevant position a disabled persons badge shall be exempt from any payment specified in Article 6(1) of this Order subject to the provisions of Article 18 of this Order

- (v) and the following item was inserted into article 5(1) of the Order:-
 - (vii) if a vehicle other than an Electric Vehicle is parked in a parking bay marked as available only for an Electric Vehicle
- (vi) and the following item was inserted as article 5(3) of the Order:-

If an Electric Vehicle is parked within the electric vehicle parking bay and the vehicle is not actively using the electric vehicle charging point then a penalty charge shall be payable by the driver of the electric vehicle

(vii) and the following item was deleted from article 7(1) of the Order:-

In the case of a vehicle in respect of which a Penalty Charge is payable under the provisions of Article 5, 18, and 19 of this Order a Penalty Charge Notice may be issued by a Civil Enforcement Officer in accordance with the requirements of the 2004 Act

and the following item was substituted in lieu thereof:-

In the case of a vehicle in respect of which a Penalty Charge is payable under the provisions of Article 5, 18, 19(1) and 19(2) of this Order a Penalty Charge Notice may be issued by a Civil Enforcement Officer in accordance with the requirements of the 2004 Act

(viii) and the following item was deleted from article 19 of the Order:-

A Official User Permit Holder's vehicle which is parked in a parking bay other than in a marked official user bay shall be exempt from any payment specified in Articles 6 and 7 of this Order.

and the following item was substituted in lieu thereof:-

- 19(1) A Official User Permit Holder's vehicle which is parked in a parking bay other than in a marked official user bay shall not be exempt from any payment specified in Articles 6 and 7 of this Order.
- (ix) and the following item was included as article 19(2) of the Order:-
 - 19(2) A Electric Vehicle which is parked in a parking bay other than in a marked Electric Vehicle Parking Bay shall not be exempt from any payment specified in Articles 6 and 7 of this Order.
- This Order shall come into operation on the 23 day of February 2016 and may be cited as the "Doncaster Borough Council (Chamber Road) (off street parking place) Order 2012 (Amendment No.2) Order 2016".
