(OFF STREET PARKING PLACES) ORDER 2008

(AMENDMENT NO. 1) ORDER 2017

Doncaster Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and all other enabling powers hereby makes the following Order: -

1 The Doncaster Borough Council (St James Street Flats Area) (Off Street Parking Places) Order 2008 shall have effect as though:-

(i) the following items were deleted from Article 5 (1) (iii) of the Order The issue of parking permits shall be limited to a maximum of 5 permits per postal address the first of which shall be supplied free of charge

(a) (i) There shall be a charge of £99.00 for the first additional parking permit purchased

(ii) There shall be a charge of £395.00 for any subsequent additional parking permits purchased

and the following items were substituted in lieu thereof:-
