The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) (Amendment No. 1, Order 2016), Various Roads, Weymouth and Portland – Revocation of Disabled Parking Bays

Dorset County Council proposes to make an Amendment Order to 'The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011' under Section 124(1)(d) of the Road Traffic Regulation Act 1984 ('the Act of 1984') and Part 6 of the Traffic Management Act 2004 and of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with statutory requirement and in compliance with the 1996 Regulations.

1. (1) In this Order:-

"disabled person" means a disabled person of a description prescribed by Regulation 4 of the Disabled Persons (Badges for Motor Vehicles) Regulations 2000;

"disabled person's badge" has the same meaning as in Regulation 11 of the Disabled Persons (Badges for Motor Vehicles) Regulations 2000;

"disabled person's vehicle" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulation 2000.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (a) a disabled person's badge in the relevant position, when:-
 - (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen;
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle;

Any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

2. The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011' is hereby revoked insofar as it relates to this Order.

Schedule 7, Part 7.5(i)

DESIGNATED PARKING SPACES FOR THE PARKING OF DISABLED PERSONS' VEHICLES ONLY

Location	Description
Ferndale Road, Weymouth	On its south west side, from a point 0.9 metres north west of the boundary between numbers 5 and 7 Ferndale Road, south eastwards for a distance of 6.6 metres.
Gallwey Road, Weymouth	On its north side; from a point 0.7 metres west of the boundary between numbers 22 and 24 Gallwey Road, eastwards for a distance of 6.6 metres.
Hereford Crescent, Weymouth	On its north side, from the easternmost end of the parking bay adjacent to numbers 9 to 11 Hereford Crescent, westwards for a distance of 3.6 metres.
Maycroft Road, Weymouth	On its west side, from a point 1 metre south of the boundary between numbers 28 and 29 Maycroft Road, northwards for a distance of 6.6 metres.
Moorfield Road, Portland	On its north side, from a point 1 metre east of the boundary between Nos 7 and 9 Moorfield Road, westwards for a distance of 6.6 metres.
Tillycombe Road, Portland	On its south side, from the boundary between numbers 9 and 11 Tillycombe Road, westwards for a distance of 6.6 metres.

This Order may be cited as 'The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) (Amendment No.1, Order 2016), Various Roads, Weymouth and Portland – Revocation of Disabled Parking Bays' and shall come into operation on the 9th day of September 2016.
