

## THE BOROUGH OF CHRISTCHURCH (VARIOUS ROADS AND PARKING PLACES) (CONSOLIDATION OF ORDERS MADE FOR WAITING AND ON STREET PARKING PLACES) (AMENDMENT No 2) ORDER 2013

**THE CHRISTCHURCH BOROUGH COUNCIL** ("the Council") acting as agent of the Dorset County Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the said County Council, under Sections 1(1), 2(1) to (3), 4(2), 32 & 35 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following Order.

- A. The Borough Of Christchurch (Various Roads And Parking Places) (Consolidation Of Orders Made For Waiting And On Street Parking Places) Order 2012 be amended as follows
- B. The following shall be added to the First Schedule to the Order Albion Road Anchor Close Fairmile Parade Lincoln Avenue Wick Point Mews
- C. The following shall be added to the Thirty Eighth Schedule to the Order Dorset Road
- D. The following shall be removed from the Thirty Eighth Schedule to the Order Douglas Avenue
- E. The following shall be removed from the Fifty First Schedule to the Order Quay Road
- F. The following shall be added to the Fifty Second Schedule to the Order Fairmile Parade
- G. The following shall be added to the Eightieth Schedule to the Order Ledbury Road
- H. The following shall be added to the Eighty First Schedule to the Order Quay Road
- I. The following shall be added to the Eighty Second Schedule to the Order Barrack Road
- J. The following shall be added to the Eight Third Schedule to the Order Clarendon Road Mudeford Lane Newcroft Gardens Portfield Road Nelson Drive
- K. Article 1.61 shall be added Waiting Limited Disabled Badge Holders Only 30 Minutes for Three Hours. No Return within 30 minutes

Save as provided in Articles 4.1, 4.2 of this Order no person shall except upon the direction or with the permission of a Civil Enforcement Officer cause or permit any vehicle to wait on the roads or sides of the roads specified in the Eightieth Schedule to this Order in the lengths of roads identified on the On-Street Plans annexed to this Order other than a vehicle lawfully displaying in the relevant positions a valid Disabled Person's Badge and Disabled Person's Parking Disc showing the quarter hour period the waiting commenced which shall be permitted to wait for a period not exceeding 30 minutes with no return within 30 minutes on the said roads or sides of the said roads specified in the Eightieth Schedule to this Order

#### L. Article 1.62 shall be added

### Waiting Limited to One Hour No Return within One Hour (except Permit Holders)

Save as provided in Articles 4.1, 4.2, 4.3 and 4.7 of this Order no person shall except upon the direction or with the permission of a Civil Enforcement Officer cause or permit any vehicle to wait for longer than one hour with no return within one hour on the roads or sides of the roads specified in the Eighty First Schedule to this Order in the lengths of roads identified on the On-Street Plans annexed to this Order

#### M. Article 1.63 shall be added

#### No Waiting Monday to Friday 8.30 – 9.30am and 2.30 – 3.30pm

Save as provided in Articles 4.1, 4.2 and 4.3 of this Order no person shall except upon the direction or with the permission of a Civil Enforcement Officer cause or permit any vehicle to wait at any time between the hours of 8.30 am to 9.30 am and 2.30 pm to 3.30 pm on Monday to Friday on the roads or sides of the roads specified in the Eighty-Third Schedule to this Order in the lengths of roads identified on the On-Street Plans annexed to this Order

#### N. Article 3.5 shall be added

#### No Stopping on Footways at any time (No Stopping)

Save as provided in Article 4.1 to this Order no person shall except upon the direction or with the permission of a Civil Enforcement Officer cause or permit any vehicle to wait or stop at any time on the footways of the roads specified in the Eighty-Second Schedule to this Order in the lengths of roads identified on the On-Street Plans annexed to this Order

# Q. The effect of this order is as listed below

Albion Road	A no waiting at any time restriction will be introduced on both sides of the road from its
	junction with Fairmile Road for a distance of 10 metres in a south westerly direction.
Anchor Close	The no waiting April to September, 10 am to 7pm restriction will be replaced with a no
	waiting at any time restriction on its western side from its junction with Mudeford for a
	distance of 24 metres in a southerly direction and on its easterly side from its junction
	with Mudeford for a distance of 31 metres in a southerly and easterly direction.
Barrack Road	A no stopping on the footway restriction will be introduced on its north eastern side
	from the boundary with 93 & 95 Barrack Road for a distance of 36 metres in a south
	easterly direction.
Dorset Road	The current bus clearway restriction will be relocated 13 metres south of its current
	location to allow the introduction of a Waiting Limited to Blue Badge Holders only
	restriction. The current no waiting and no loading at any time restriction will be
	reduced in length by 13 metres.
Douglas	The Waiting Limited to Blue Badge Holders only restriction outside of no 17 Douglas
Avenue	Avenue will be removed.
Fairmile	A waiting limited to 2 hours, Monday to Saturday, 8am to 6pm, No return within 2 hours
Parade	will be introduced for the entire length of its south western side a north westerly
	direction.
	A no waiting at any time restriction will be introduced on its north eastern side for the
	entire length.
Lincoln	A no waiting at any time restriction will be introduced on both sides of the road from the
Avenue	junction of Suffolk Avenue for a distance of 6 metres in a north westerly direction.
Moffat Road	The no waiting at any time restriction on its northern side at its junction with
	Livingstone Road side will be extended for a distance of 24 metres in a westerly
	direction.
Mudeford	The current no waiting April to September, 10 am to 7pm restriction on its southern
	side from the boundary of no's 137 & 139 Mudeford to the boundary of no's 141 & 143
	Mudeford will be replaced with a no waiting at any time restriction.
Newcroft	A no waiting Monday to Friday 8.30am to 9.30am and 2.30pm to 3.30pm restriction will
Gardens	be introduce d on its western side for the entire length.
Purewell	The Waiting Limited to 30 Minutes Monday to Saturday, 10am to 6pm, No return within
	30 minutes restriction on its southern side from a point 8 metres west of its junction
	with Fernlea for a distance of 26 metres in an easterly direction, will be replaced with a
	no waiting at any time restriction.
Quay Road	The existing Waiting Limited, Mon to Sat, 8am to 6pm, 1 hour, No Return within 1 hour,
	Except Permit Holders Only Restriction will become a Waiting Limited to 1 hour, No
	Return within 1 hour Except Permit Holders Only restriction.
Stour Road	The current waiting limited to 30 minutes 10am to 6pm, no return within 1 hour
	restriction on its north western side will be removed from a point 3 metres north east of
	the boundary of 83a & 85 for a distance of 15 metres in a south westerly direction and
	replaced with a no waiting at any time restriction.
Suffolk	A no waiting at any time restriction will be introduced on its north-western side from the
Avenue	boundary 36 & 38 Suffolk Avenue for a distance of 39 metres in a north easterly
	direction.
Wick Point	A no waiting at any time restriction will be introduced on the northern side from its
Mews	junction with Wick Lane to the boundary of 15 & 17 Wick Point Mews and on the
	southern side from its junction with Wick Lane for a distance of 11 metres in a westerly
	direction, from a point 25 metres west of its junction with Wick Lane to the junction with
	the car park, and from a distance 83 metres west of its junction with Wick Lane in a for
	a distance of 17 metres in a westerly and southerly direction.
