

**The Borough of Weymouth and Portland  
(Waiting Restrictions) (Consolidation) Order 2011 (as amended)  
(Amendment No.12 Order 2013)**

The Council of the Borough of Weymouth and Portland (hereinafter referred to as “the Council”) pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Council of the County of Dorset in exercise of its powers of the said County Council under Section 1, 2, 3, 4, 32, 35, 45-56 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”), the relevant powers under Part 6 of the Traffic Management Act 2004 and all other enabling powers, in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and after consultation with the Chief Officer of Police and with the consent of the County Council of Dorset in accordance with Section 39(3) of the Act of 1984, hereby makes the following Order which varies The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) hereinafter called “the Principal Order”. Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.

1. This Order shall come into operation on Monday 1 July 2013 and may be cited as The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) (Amendment No.12 Order 2013).
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. In this Order “the Principal Order” means “The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended)”. Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
4. The Principal Order shall be amended as follows:-
  - (1) In Schedule 1, Part 1.1 (No Waiting at Any Time), the **Amendments** detailed below are to be made under the roads named below;

**Dorchester Road** – under (i) (On its east side) **Delete** (i) and (l) in their entirety and **Insert** new (i), (l), (o) and (p) as follows:

- “(i) From a point 90 metres south of its junction with Littlemoor Road, southwards for a distance of 28 metres.
- (l) From a point 67 metres south of its junction with Littlemoor Road, northwards to a point 90 metres north of its junction with Beech Road.
- (o) From a point 52 metres south of its junction with Old Station Road, southwards for a distance of 44 metres.
- (p) From a point 22 metres south of its junction with Old Station Road, northwards to a point 37 metres north of its junction with Victoria Avenue.”

**Dorchester Road** – under (ii) (On its west side) **Delete** (s) and (t) in their entirety and **Insert** new (s) and (t) as follows:

“(s) From the boundary between numbers 827 and 829 Dorchester Road, northwards for a distance of 101 metres.

(t) From a point 84 metres south of its junction with Elwell Street, northwards to a point 4.8 metres south west of the south west building line of number 879 Dorchester Road.”

**Elwell Street – Delete** (i) and (ii) in their entireties and **Insert** new (i) and (ii) as follows;

“(i) On its north side, from its junction with The Ridgeway, westwards for a distance of 16.2 metres.

(ii) On its south side, from its junction with Dorchester Road, westwards for a distance of 18.5 metres.”

**Old Station Road – Delete** (ii) in its entirety and **Insert** new (ii) as follows;

“(ii) On its south side, from its junction with Dorchester Road, eastwards for a distance of 2 metres.”

**(2)** In Schedule 1, Part 1.1 (No Waiting at Any Time), **Insert** new as follows;

**“Greenway Road**

(i) On its north and west sides, from its junction with Dorchester Road, eastwards and then northwards for a distance of 35 metres.

(ii) On its south and east sides, from its junction with Dorchester Road, eastwards and then northwards for a distance of 38 metres.”

**(3)** In Schedule 6, **Delete** Part 6.1 (Limited Waiting, Maximum Stay 30 minutes, No Return Within 30 minutes) in its entirety and **Insert** new Part 6.1 as follows;

**“Part 6.1  
Limited Waiting, Maximum stay 1 hour, No Return Within 1 hour,  
Monday to Saturday, 8am to 6pm**

**Dorchester Road**

(i) On its east side, from a point 22 metres south of its junction with Old Station Road, southwards for a distance of 30 metres.”
