

**The Borough of Weymouth and Portland
(Waiting Restrictions) (Consolidation) Order 2011
(as amended) (Amendment No 13 Order 2013)**

The Council of the Borough of Weymouth and Portland (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Council of the County of Dorset in exercise of its powers of the said County Council under Section 1, 2, 3, 4, 32, 35, 45-56 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), the relevant powers under Part 6 of the Traffic Management Act 2004 and all other enabling powers, in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and after consultation with the Chief Officer of Police and with the consent of the County Council of Dorset in accordance with Section 39(3) of the Act of 1984, hereby makes the following Order which varies The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) hereinafter called "the Principal Order". Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.

1. This Order shall come into operation on 16 September 2013 and may be cited as The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) (Amendment No 13 Order 2013).
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. In this Order "the Principal Order" means "The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended)". Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
4. The Principal Order shall be amended as follows:-

- (1) In Schedule 7, Part 7.5(i) (Designated Parking Spaces for the parking of Disabled Persons' Vehicles Only) the **Amendments** detailed below are to be made under the roads named below:-

Avenue Road – Under (i) (on its south side), **Delete** (b) in its entirety

Benville Road – Delete in its entirety

Bradford road – Insert new (ii) as follows;

- "(ii) On its north side, from a point 1.3 metres west of the boundary between numbers 13 and 15 Bradford Road, eastwards for a distance of 6.1 metres."

Chickerell Road - Under (i) (on its south side), **Delete** (b) in its entirety

Louviers Road – Under (i) (On its north east side), Insert new (b) as follows;

"(b) From a point 0.7 metres south east of the boundary between numbers 43 and 45 Louviers Road, north westwards for a distance of 5.5 metres."

Rodwell Avenue – Delete (i) in its entirety and **Re-number** existing (ii) as (i) accordingly.

The Ridgeway – Delete in its entirety.

Tollerdown Road – Delete in its entirety

Victoria Street – Delete (ii) in its entirety.

(2) In Schedule 7, Part 7.5(i) (Designated Parking Spaces for the parking of Disabled Persons' Vehicles Only) **Insert** the following:-

"Southwell Street

(i) On its north side, from a point 3.8 metres west of the boundary between numbers 53 and 55 Southwell Street, eastwards for a distance of 5.5 metres."
