

**The Borough of Weymouth and Portland
(Waiting Restrictions) (Consolidation) Order 2011
(as amended) (Amendment No 16 Order 2014)**

The Council of the Borough of Weymouth and Portland (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Council of the County of Dorset in exercise of its powers of the said County Council under Section 1, 2, 3, 4, 32, 35, 45-56 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), the relevant powers under Part 6 of the Traffic Management Act 2004 and all other enabling powers, in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and after consultation with the Chief Officer of Police and with the consent of the County Council of Dorset in accordance with Section 39(3) of the Act of 1984, hereby makes the following Order which varies The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) hereinafter called "the Principal Order". Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.

1. This Order shall come into operation on Monday 27th January 2014 and may be cited as The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) (Amendment No 16 Order 2014).
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. In this Order "the Principal Order" means "The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended)". Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
4. The Principal Order shall be amended as follows:-
 - (1) In Schedule 3, Part 3.3 (Restricted Area Outside of a School, No Stopping between 8am and 5pm, Monday to Friday) **Delete** Grove Road and Three Yards Close in their entirety.
 - (2) In Schedule 7, Part 7.5(i) (Designated Parking Spaces for the parking of Disabled Persons' Vehicles Only) the **Amendments** detailed below are to be made under the roads named below:-

Avalanche Road –Insert new (iii) as follows;

"(iii) On its west side, from the boundary between numbers 39 and 41 Avalanche Road, northwards for a distance of 5 metres."

Bridlebank Way – Delete (ii) and (iii) in their entirety.

Cromwell Road – Under (i) (On its west side) **Delete** (a) in its entirety and **Insert** new (a) as follows;

"(a) On its west side, from a point 12 metres south of its junction with Abbotsbury Road, southwards for a distance of 6.6 metres."

Cromwell Road – Insert new (ii) as follows;

- “(ii) On its east side, from the boundary between numbers 64 and 66 Cromwell Road, northwards for a distance of 4.8 metres.”
- (3) In Schedule 7, Part 7.6(iv) (Bus/Coach Sopping Area 8.30am to 5pm) **Delete** Grove Road in its entirety.
- (4) In Schedule 8, Part 8.1(Parking Places for Pay and Display parking at All Times), **Delete** 8.1(1) (Castletown) in its entirety and **Re-number** 8.1(2) to 8.1(4) as 8.1(1) to 8.1(3) accordingly.
- (5) In Schedule 8, Part 8.2 (Tariffs and Conditions of use), **Delete** 8.2(1) (Castletown) in its entirety and **Re-number** 8.2(2) to 8.2(4) as 8.2(1) to 8.2(3) accordingly.
